- Mayor's team update: Awareness of the barriers APD is running into with "Red Flag Law".
 Had a press conference to discuss possible changes
- b. The GVTF recognizing the issues with the name "Red Flag Law" and will collectively refer to it as ERPO moving forward

- 6. Mayor's team is requesting \$2million in recurring funding
- 7. Legislation to fund statewide violence intervention permanently

8. Committee Updates

a. Family and Community Engagement

Working to recommend Certified Peer Support Workers and Community Health Workers as community liaisons for better communication between city entities, resources and programs. Nichole suggested funding through OEI for the training at CHW training at CNM. Comes with living wage stipend for the one semester program. We currently have no african american CHWs. This program starts Jan 27th and would have a total of 12 participants

b. Positive Youth Development

No update. Committee Chair is not attending and December's meeting was canceled by Chair

c. Trauma Informed Responses

New members on committee from Crossroads for Women, MDC, Wings for Life. Education-Developing a new language on what trauma is, how differently people work through it and how we can support as a community. Understanding and recognizing that perpetrators are often victims themselves. Starting to think about where we can facilitate trainings and how we can work together with existing entities like ACS Contractor Trainers

d. Economic Stability and Mobility

Finalized list of assets, identifying priorities. Completed list of interview questions for assets. Next committee will begin to schedule interviews with the four targeted assets. Next meeting is Wednesday Dec. 21
