# MINUTES – September 3, 2024 Special Hearing

This Albuquerque-Bernalillo County Air Quality Control Board ("Board") hearing was conducted in a hybrid format with both in-person and remote participation via Zoom video conference.

## 1. CALL TO ORDER

Chair Galewsky called the meeting to order at 9:07 a.m.

Board Liaison Anita SdeArmijo called roll and the Chair determined a quorum was present.
