# MINUTES – November 13, 2024

This Albuquerque-Bernalillo County Air Quality Control Board ("Board") meeting was conducted in a hybrid format with both in-person and remote participation via Zoom video conference.

### 1. CALL TO ORDER

Chair Galewsky called the meeting to order at 5:30 p.m.

Board Liaison Anita SdeArmijo called roll and the chair determined a quorum was present.

Air Program Administrator Catalina Lehner gave the Zoom overview.

# 5. DISCUSSION & ACTION ITEMS

A. Resolution 2024-1, Determining Reasonable Notice of Public Meetings of the AQCB

Ms. Lehner gave a summary of Resolution 2024-01 and answered questions. Member Armijo moved to adopt resolution 2024-01. Member Eberlein seconded and the motion passed by the following vote:

B. Resolution 2024-2, Setting the Official List of Regular AQCB Meetings for the Year 2025

Ms. Lehner gave a brief statement about resolution 2024-02. Member Cudney-Black moved to approve Resolution 2024-02. Member Armijo seconded and the motion passed by the following vote:

C. Creation of a Committee Regarding the Open AQCB Attorney Position

Council Sedillo Lopez stated that she when she last spoke with the city's attorney, no one had applied for the position and that she would stay on until one is hired.

After a brief discussion, Members Armijo and Richards volunteered to be on the subcommittee.

- D. The Board will consider whether or not to go into closed session with the Board Attorney to discuss i) pending litigation: AQCB and BCC of Bernalillo County vs. CoA (202-CV-2-23-09295) and GCC Rio Grande et al vs AQCB and CoA (D-202-CV-2023-09435), and ii) appeals of Clean Cars II regulations and the HEEI regulation.
  - The board will discuss, make a motion with reasonable specificity, and vote whether or not to go into closed session, following procedures outlined in Section 10-15-1 (I) of the OMA. Exceptions to open meetings are outlined in Section 10-15-1 (H).

After a brief discussion, Member Richards moved to go into closed session regarding the pending litigation. Member Eberlein seconded. The motion passed by the following vote:
