**A.** Residency-Organization Recommendations

Brueggemann provided a recap of the previous week's meeting and then shared a spreadsheet with the final scores all the organizations that submitted their applications. The five selected organization were Dellsly Group, FUSION, Keshet Dance Company, National Institute of Flamenco, and Puha Hubiya.

The Board had a brief discussion regarding their satisfaction of the diversity and genres of their final selection.

A. Lipman moved to approve the final selection as reported; N. Zastudil seconded; and all others approved.

Acknowledging that the UETF Committee has worked tirelessly for over a year and may be suffering review and scoring burn out, S. Brueggemann recommended that the UETF Committee members consider attending an introduction meeting to provide oversight/guidance to the organizational representatives via a special working meeting. From then the makeup of the artist selection panel could evolve. A. Lipman concurred. She advised them that she would arrange for the meeting to take place the week after Labor-day.

S. Allen voiced his preference that each of the organizations should only be permitted to have one-member serve on the artist selection panel. Everyone agreed and staff will communicate this while also encouraging each organization to work with other members of their staff throughout the process, while only have one "vote" or set of scores.
