PATRICK AND BEVERLY DEGRUYTER Series request(s) a special exception to Section 14-16-2-6(B)(1): a CONDITIONAL USE for a proposed accessory living quarters for all or a portion of Lot(s) 21, Block(s) 12, Tract(s) 11, HEIGHTS RESERVOIR ADDN zoned R-1, located on 307 QUINCY ST NE (K-17)

STATEMENT OF FACTS: The applicant, Patrick and Beverly Degruyter, request a conditional use for a proposed accessory living quarters at 307 Quincy St NE. The Degruyter's have owned the property for 7 years. Mr. Degruyter testified that he would like to construct a 325 square foot accessory living quarters that will have full upgraded utilities, (plumbing and heating). The use of the accessory building will consist of a workshop and studio. The proposed accessory structure is approximately 40' from the existing dwelling. Mr. Degruyter stated that does not have a contractor. Mr. Degruyter spoke with the nearby neighbors and had no objections to his request. He testified that this development will not cause any harm to the surrounding structures. This matter was referred to facilitation by The City of Albuquerque Land Use Facilitation Program. However, there was no need for a facilitated meeting. There is no letters of opposition in the file, nor was there any opposition at the hearing. The yellow signs were posted.

Based on all of the testimony and a review of the entire file, it is determined there is substantial evidence to make the following findings and conclusions:

FINDINGS AND CONCLUSIONS: I find that this request complies with Section 14. 16. 4. 2. (C). 1., for the granting of a conditional use upon a finding that the proposed use will not cause injury to the neighborhood, adjacent property or the community, nor will it be damaged by surrounding structures.

DECISION: Approved.

The approval is subject to the submitted site plan, as required. Any substantial changes to the site plan, as determined by the Zoning Enforcement Division, shall require the scheduling of an additional Public Hearing.

A Building Permit must be applied for at the Building Permit Desk which is located at the Plaza del Sol Building, Ground Level on the east side of the lobby.

If you wish to appeal this decision, you may do so by 5:00 p.m., on June 14, 2012 in the manner described below:

Appeal is to the Board of Appeals within 15 days of the decision. A filing fee of \$105.00 shall accompany each appeal application, as well as a written explanation outlining the reason for appeal and a copy of the ZHE decision. Appeals are taken at 600 2nd Street, Plaza Del Sol Building, Ground Level, Planning Application Counter located on the west side of the lobby. **Please present this letter of notification when filing an appeal.** When an application is withdrawn, the fee shall not be refunded.

An appeal shall be heard by the Board of Appeals within 45 days of the appeal period and concluded within 75 days of the appeal period. The Planning Division shall give written notice of an appeal, together with a notice of the date, time and place of the hearing to the applicant, a representative of the opponents, if any are known, and the appellant.

Please note that pursuant to Section 14. 16. 4. 4. (B)., of the City of Albuquerque Comprehensive Zoning Code, you must demonstrate that you have legal standing to file an appeal as defined.

You will receive notice if any other person files an appeal. If there is no appeal, you can receive building permits any time after the appeal deadline quoted above, provided all conditions imposed at the time of approval have been met. However, the Zoning Hearing Examiner may allow issuance of building permits if the public hearing produces no objection of any kind to the approval of an application. To receive this approval, the applicant agrees in writing to return the building permit or occupation tax number.

Successful applicants are reminded that other regulations of the City must be complied with, even after approval of a special exception is secured. This decision does not constitute approval of plans for a building permit. If your application is approved, bring this decision with you when you apply for any related building permit or occupation tax number. Approval of a conditional use or a variance application is void after one year from date of approval if the rights and privileges are granted, thereby have not been executed or utilized.
