NOTIFICATION OF DECISION

CORRINE BANDERA request(s) a special exception to Section 14-16-4-13: a STATUS ESTABLISHED BUILDING REVIEW to allow two existing dwelling units on one lot for all or a portion of Lot(s) 177B2B, MRGCD MAP 35 zoned RA-2, located on 3308 CAMILO LN NW (H-12)

STATEMENT OF FACTS: The applicant, Corrine Bandera requests a status established building review to allow two existing dwelling units on one lot. This matter was originally scheduled for March 20, 2012 but was deferred to the April 17, 2012 meeting in order to obtain additional information. It was then again deferred to May 15, 2012 for the same reasons. Ms. Bandera testified at the hearing that the home has been in her family since before she was born. There is evidence in the file that shows the dwelling existed prior to the inception of the Zoning Code. Ms. Bandera provided the following documents of proof with her application: an affidavit of Corrine Bandera, affidavit of Jose Lucero and a Surveyor's Certificate from 1987 showing the plat filing date of August 13, 1976. We received a memorandum on May 10, 2012 from Ed Boles, Historic Preservation Planner, indicating that he and Jonathan Turner of the Code Enforcement Division visited the premises and found that the dwelling units pre-date World War II. Mr. Boles report included photos of the house, door, lumber, roof, water pipes, and a 1959 aerial photo of the property. It also included photographs from the New Mexico Historic Building Inventory. Delores Shambert testified at the hearing in support of Ms. Bandera. She claims the home was her grandparents home. There is a letter of opposition from William Herring, President of the Los Duranes Neighborhood Association in the file. However, Mr. Herring reviewed the document and report provided by Mr. Boles. He has notified our office that he no longer has opposition to the request. The yellow signs were posted.

Based on all of the testimony and a review of the entire file, it is determined that there is substantial evidence to make the following findings and conclusions:

FINDINGS AND CONCLUSIONS: I find that as provided for in Section 14. 16. 4. 13. (C). of the Zoning Ordinance, the current use of this status established building is nonconforming. The subject property is clearly identified by a site plan and the improvements upon it are accurately depicted. Further, the continuance of the use will not be contrary to the public health, safety or welfare of the community. The use, as currently operated and/or maintained, did not, and the continuance of the use is not likely to, significantly interfere with the enjoyment of, or be injurious to, other land in the vicinity. There will be no significant public purpose served by requiring removal of the use and the use, if continued, will not be damaged by surrounding structures or activities.

Finally, continuance of the use does not create a significant disparity between the existing zoning and the status established building.

DECISION: Approved with conditions.

CONDITIONS: Any alteration of up to 25% to the total square footage of the existing dwellings will require a separate application for Special Exception for Expansion of Non-Conforming Use. This approval will be immediately vacated if the applicant does not comply with these conditions.

The approval is subject to the submitted site plan, as required. Any substantial changes to the site plan, as determined by the Zoning Enforcement Division, shall require the scheduling of an additional Public Hearing.

If you wish to appeal this decision, you may do so by 5:00 p.m., on June 11, 2012 in the manner described below:

Appeal is to the Board of Appeals within 15 days of the decision. A filing fee of \$105.00 shall accompany each appeal application, as well as a written explanation outlining the reason for appeal and a copy of the ZHE decision. Appeals are taken at 600 2nd Street, Plaza Del Sol Building, Ground Level, Planning Application Counter located on the west side of the lobby. **Please present this letter of notification when filing an appeal.** When an application is withdrawn, the fee shall not be refunded.

An appeal shall be heard by the Board of Appeals within 45 days of the appeal period and concluded within 75 days of the appeal period. The Planning Division shall give written notice of an appeal, together with a notice of the date, time and place of the hearing to the applicant, a representative of the opponents, if any are known, and the appellant.

Please note that pursuant to Section 14. 16. 4. 4. (B)., of the City of Albuquerque Comprehensive Zoning Code, you must demonstrate that you have legal standing to file an appeal as defined.

You will receive notice if any other person files an appeal. If there is no appeal, you can receive building permits any time after the appeal deadline quoted above, provided all conditions imposed at the time of approval have been met. However, the Zoning Hearing Examiner may allow issuance of building permits if the public hearing produces no objection of any kind to the approval of an application. To receive this approval, the applicant agrees in writing to return the building permit or occupation tax number.

Successful applicants are reminded that other regulations of the City must be complied with, even after approval of a special exception is secured. This decision does not constitute approval of plans for a building permit. If your application is approved, bring this decision with you when you apply for any related building permit or occupation tax number. Approval of a conditional use or a variance application is void after one year

from date of approval if the rights and privileges are granted, thereby have not been executed or utilized.
