MOWRER ON BEHALF OF THE ALBUQUERQUE POLICE OFFICERS' ASSOCIATION AND AGAINST THE ALBUQUERQUE POLICE DEPARTMENT FOR VIOLATING CBA SECTION 10-7E-1 et seq. Attorney Evan Crocker appeared on behalf of the City and Attorney Frederick Mowrer appeared on behalf of APOA.
