LB 22-36

I, Milagro Padilla, representative for the Communications Workers of America (CWA) am hereby submitting union authorization cards naming CWA as the selected bargaining agent pursuant to the City's Labor Management Relations Ordinance. CWA requests the Board certify CWA as the exclusive bargaining agent for all Behavioral Health Responders, Community Responders, Mobile Crisis Team Clinician and Street Outreach Resource Coordinators in the City's Community Safety Department.

This petition includes 25 authorization cards. CWA requests immediate certification of CWA as the employees' exclusive bargaining agent.

Workers in the positions listed above are currently unrepresented by a bargaining agent. We believe the unit to include 39 potential workers who are headquartered at 5400 Gibson Blvd SE 87108 their phone number is 505-768-4227. The employees work in Albuquerque, New Mexico.
