ORDINANCE

AUTHORIZING THE ISSUANCE AND SALE OF THE CITY OF ALBUQUERQUE, NEW MEXICO GROSS RECEIPTS TAX IMPROVEMENT REVENUE BONDS IN ONE OR MORE SERIES IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$22,500,000 TO FINANCE THE (1) COST OF DESIGNING, DEVELOPING, CONSTRUCTING, RECONSTRUCTING, REHABILITATING, RENOVATING, MODERNIZING, SIGNING, ENHANCING AND OTHERWISE IMPROVING CERTAIN CAPITAL IMPROVEMENTS, INCLUDING THE SOUTHWEST PUBLIC SAFETY CENTER, CITY YOUTH SHELTERS, CIBOLA LOOP MULTIGENERATIONAL CENTER, GIBSON HEALTH HUB, WESTSIDE EMERGENCY HOUSING SHELTER, THE ALBUQUERQUE RAILYARDS, AND THE ACQUISITION OF A LAW ENFORCEMENT HELICOPTER, AND (2) PAYING EXPENSES RELATED TO ISSUANCE OF THE BONDS; PROVIDING FOR THE PAYMENT OF THE SERIES 2024 BONDS FROM CERTAIN GROSS RECEIPTS TAX REVENUES; PROVIDING FOR THE COLLECTION OF CERTAIN GROSS RECEIPTS TAXES; APPROVING THE DELEGATION OF AUTHORITY TO MAKE CERTAIN DETERMINATIONS REGARDING THE SALE OF THE SERIES 2024 BONDS PURSUANT TO THE SUPPLEMENTAL PUBLIC SECURITIES ACT; PROVIDING FOR THE TERMS AND OTHER DETAILS CONCERNING THE SERIES 2024 BONDS; PROVIDING FOR CERTAIN DOCUMENTS PERTAINING TO THE SERIES 2024 BONDS; RATIFYING ACTION PREVIOUSLY TAKEN; REPEALING ALL ACTIONS INCONSISTENT WITH THIS ORDINANCE; AUTHORIZING THE TAKING OF OTHER ACTIONS IN CONNECTION WITH THE ISSUE AND SALE OF THE SERIES 2024 BONDS.

Capitalized terms used in the following preambles are defined in Section 1 of this Bond Ordinance, unless the context requires otherwise.

1 WHEREAS, the City is a legally and regularly created, established, organized and
2 existing municipal corporation under the general laws of the State and its home rule
3 charter; and

4 WHEREAS, the City has Home Rule Powers; and

5 WHEREAS, pursuant to Section 7-9-4 NMSA 1978, the State imposes a gross
6 receipts tax on persons engaging in business in the State, and pursuant to Section 7-1-
7 6.1 NMSA 1978, the City receives monthly distributions from the New Mexico Taxation
8 and Revenue Department of a portion (currently 1.225% of the taxable gross receipts
9 reported for the City for the month for which such remittance is made) of such gross
10 receipts taxes; and

11 WHEREAS, pursuant to Sections 7-1-6.1 NMSA 1978 and Section 7-1-6.46, the
12 City receives monthly distributions from the New Mexico Taxation and Revenue
13 Department in lieu of gross receipts tax revenue that the City would have received but for
14 the deductions provided by Sections 7-9-92 and 7-9-93 NMSA 1978; and

15 WHEREAS, the City has previously sold and delivered Tax Obligations of which
16 there remain Outstanding on the date of adoption of the Bond Ordinance the following
17 aggregate principal amounts:

2 WHEREAS, except for the Tax Obligations listed above, on the date of adoption
3 of this Bond Ordinance, no portion of the State-Shared Gross Receipts Tax Revenues
4 has been pledged to the payment of any other Tax Obligations; and

5 WHEREAS, the City desires to issue and sell the Series 2024 Bonds in an
6 aggregate principal amount not to exceed \$22,500,000 to pay the costs and expenses of
7 the Project (including reimbursing the City with all or a portion of the proceeds of the
8 Series 2024 Bonds for the use of legally available moneys of the City previously expended
9 to pay a portion of the costs of the Project); and

10 WHEREAS, the Series 2024 Bonds shall be secured by a first (but not an exclusive
11 first) lien on the State-Shared Gross Receipts Tax Revenues on a parity with the lien on
12 State-Shared Gross Receipts Tax Revenues of the Senior Tax Obligations; and

13 WHEREAS, the Act provides that any law which authorizes the pledge of any or
14 all of the State-Shared Gross Receipts Tax Revenues to the payment of any revenue
15 bonds issued pursuant to the Act or which affects the State-Shared Gross Receipts Tax
16 Revenues, or any law supplemental thereto or otherwise appertaining thereto, shall not
17 be repealed or amended or otherwise directly or indirectly modified in such a manner as
18 to impair adversely any such outstanding revenue bonds, including the Series 2024
19 Bonds, unless such outstanding revenue bonds, including the Series 2024 Bonds, have
20 been discharged in full or provision has been fully made therefor; and

21 WHEREAS, the City is authorized by the Act to issue and sell the Series 2024
22 Bonds to accomplish the Project; and

23 WHEREAS, the Council has determined that it is in the best interest of the City
24 and its residents that the Series 2024 Bonds be issued for the design, development,
25 construction, reconstruction, rehabilitation, renovation, modernization, signage,
26 enhancement and other improvement of the Project; and

27 WHEREAS, the Council determines that it is in the best interest of the City and its
28 residents to sell the Series 2024 Bonds to the Investment Bankers at the sale price, and
29 on the terms set forth in the Sale Certificate; and

30 WHEREAS, there has been on deposit with the City Clerk and presented to the
31 City Council:

4 WHEREAS, all required authorizations, consents or approvals of any State
5 governmental body, agency or authority for the authorization, execution and delivery of
6 the Series 2024 Bonds which are required to have been obtained by the date of the
7 adoption of the Bond Ordinance have been obtained, and which will be required to be
8 obtained prior to the Closing Date, will have been obtained by that Closing Date; and

9 WHEREAS, the City recognizes the pressing need to fully fund several projects
10 underway that enhance the well-being and quality of life of its residents across all age
11 groups and demographics; and

12 WHEREAS, the Cibola Loop Multi-Generational Center will be paramount in
13 fostering a sense of community, providing vital resources, and promoting
14 intergenerational interaction and support among seniors, children, and families, thereby
15 enriching social cohesion and collective resilience for Albuquerque's Westside residents;
16 and

17 WHEREAS, the much needed improvements to the Westside Emergency Housing
18 Shelter and the multiple phases underway at the Gibson Health Hub will address
19 homelessness through the provision of transitional housing and sheltering not only
20 ensures the safety and dignity of unhoused individuals but also offers a pathway to
21 stability, access to essential services, and opportunities for reintegration into society, thus
22 fostering a more inclusive and compassionate community; and

23 WHEREAS, investing in shelter and support services tailored to teens and young
24 adults is essential for facilitating their successful transition to sustained housing,
25 empowering them to overcome barriers to independence, and fostering self-sufficiency
26 and resilience among this vulnerable population; and

27 WHEREAS, enhancing public safety through the acquisition of a state-of-the-art
28 police helicopter and the Southwest Public Safety Center enables law enforcement to
29 effectively respond to emergencies, combat crime, and safeguard the well-being of
30 residents, thereby promoting a safer and more secure environment for all; and

1 WHEREAS, fully funding the projects expected to be completed within the coming
2 twelve months is crucial for accelerating progress, maximizing efficiency, and realizing
3 the anticipated benefits, thereby demonstrating the City's commitment to timely and
4 impactful service delivery.

5 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY
6 OF ALBUQUERQUE:

7 SECTION 1. DEFINITIONS AND RULES OF CONSTRUCTION.

8 (A) DEFINITIONS. As used in the Bond Ordinance, the following terms
9 have the meanings specified, unless the context clearly requires otherwise:

10 ACT. Sections 3-31-1 to 3-31-12 and Sections 6-14-8 to 6-14-11 NMSA
11 1978, as amended, the City Charter, the Home Rule Powers and all enactments of the
12 Council, including the Bond Ordinance, relating to the issuance of the Series 2024 Bonds.

13 AUTHORIZED DENOMINATIONS. Denominations of \$5,000 and integral
14 multiples thereof.

15 AUTHORIZED OFFICER. The City's Mayor, Chief Administrative Officer,
16 Chief Financial Officer, Director of Department of Finance and Administrative Services,
17 Treasurer, or other officer or employee of the City when designated by a certificate signed
18 by the Mayor of the City from time to time.

19 BOND COUNSEL. An attorney at law or a firm of attorneys, designated by
20 the City, of nationally recognized standing in matters pertaining to the issuance of bonds
21 issued by states and their political subdivisions.

22 BOND INSURANCE POLICY. A municipal bond insurance policy issued by
23 a Credit Source insuring the payment when due of the principal of and interest on Tax
24 Obligations.

25 BOND ORDINANCE. This ordinance, being City Twenty-Sixth Council Bill
26 No. F/S O-24-10, as amended or supplemented from time to time.

27 BOND PURCHASE AGREEMENT. The Bond Purchase Agreement among
28 the City and the Investment Bankers relating to the sale of the Series 2024 Bonds to the
29 Investment Bankers.

30 BOND REGISTER. The books maintained by the Registrar for the
31 registration, transfer and exchange of the Series 2024 Bonds.

1 BUSINESS DAY. Any day other than (i) a Saturday or Sunday, or (ii) any
2 day in which the offices of the City or the offices of banks located in the State are
3 authorized or required to remain closed.

4 CITY. The City of Albuquerque, in the County of Bernalillo and State of New
5 Mexico.

6 CITY CHARTER. The Charter of the City adopted pursuant to the laws of
7 the State at a special election on June 29, 1971 and amended thereafter from time to
8 time.

9 CLOSING DATE. The date of the original issue, sale and delivery to the
10 Investment Bankers or their designee of the Series 2024 Bonds.

11 CODE. The Internal Revenue Code of 1986, as amended from time to time.
12 Each reference to a section of the Code in the Bond Ordinance shall be deemed to include
13 the final and temporary United States Treasury regulations thereunder, as the same may
14 be in effect from time to time, to the extent the same are applicable, unless the context
15 clearly requires otherwise.

16 COMPLETION DATE. The date of completion of the design, development,
17 construction, reconstruction, rehabilitation, renovation, modernization, signage,
18 enhancement and other improvement of the Project or, as to that portion of the Project to
19 be funded by the Series 2024 Bonds and as certified pursuant to Section 16.

20 CONTINUING DISCLOSURE UNDERTAKING. The undertaking of the City
21 for the benefit of Owners and beneficial owners pursuant to which the City will agree that,
22 while the Series 2024 Bonds are Outstanding, the City will annually provide certain
23 financial information and operating data and will provide notice of certain events in
24 accordance with Rule 15c2-12 promulgated under the Securities Exchange Act of 1934,
25 as amended.

26 COUNCIL. The governing body in which is vested the legislative power of
27 the City.

28 COUNSEL. An attorney at law (who may be counsel to the City).

29 CREDIT FACILITY. A letter of credit, line of credit, Bond Insurance Policy
30 or Reserve Fund Insurance Policy, guaranty or similar agreement provided by a Credit
31 Source whose senior unsecured debt is rated no lower than the current rating on the

1 applicable Obligations and in any event no lower than "AAA" by Moody's, S&P and Fitch
2 to the extent each such rating agency is then rating such Obligations to provide support
3 to pay the purchase price of, or the payment when due of the principal of and interest on,
4 such Obligations.

5 CREDIT SOURCE. Any bank, insurance company or other financial
6 institution which provides a Credit Facility for a series of Obligations.

7 CUSIP. A Committee on Uniform Securities Identification Procedures
8 number used to identify financial instruments including municipal bonds.

9 DEBT SERVICE REQUIREMENTS. With respect to Tax Obligations, as
10 applicable, and for any given period, the sum of: (1) the amount required to pay the
11 interest, or to make reimbursements for payments of interest, becoming due on the Tax
12 Obligations during that period, plus (2) the amount required to pay the principal or
13 accreted value, or to make reimbursements for the payment of principal or accreted value,
14 becoming due on Tax Obligations during that period, whether at maturity, an accretion
15 term date or upon mandatory sinking fund redemption dates, plus (3) the periodic
16 payments required to be made by the City pursuant to a qualified exchange agreement
17 minus (4) the periodic payments to be received by the City pursuant to a qualified
18 exchange agreement. No payments required for any Tax Obligations which may be
19 tendered or otherwise presented for payment at the option or demand of the owners or
20 holders of the Tax Obligations, or which may occur because of the exercise of an option
21 by the City, or which may otherwise become due by reason of any other circumstance or
22 contingency, including acceleration or exchange termination payments, which constitute
23 other than regularly scheduled payments of principal, accreted value, interest or other
24 regularly scheduled payments on the Tax Obligations shall be included in any
25 computation of Debt Service Requirements for that period.

26 Unless, at the time of computation of Debt Service Requirements, payments on
27 the Tax Obligations are owed to, or the Tax Obligations are owned or held by, the provider
28 of a Credit Facility pursuant to the provisions of that Credit Facility, the computation of
29 interest for the purposes of this definition shall be made without considering the interest
30 rate payable pursuant to a Credit Facility.

1 In any computation of Debt Service Requirements relating to the issuance of
2 additional Senior Tax Obligations, there shall be deducted from that computation of Debt
3 Service Requirements amounts and investments which are irrevocably committed to
4 make designated payments on the Tax Obligations during the applicable period,
5 including, without limitation money on deposit in any debt service account, amounts on
6 deposit in an escrow account irrevocably committed to make designated payments on the
7 Tax Obligations, during the applicable period and earnings on such investments which
8 are payable during the applicable period.

9 For the purpose of the definition of Debt Service Requirements, the accreted value
10 of capital appreciation bonds becoming due shall be included in the calculation of accrued
11 and unpaid and accruing interest and principal only from and after the date which is one
12 year prior to the date on which the accreted value becomes payable. In addition, the
13 definition of Debt Service Requirements shall include any Expense Component.

14 DEFEASANCE OBLIGATIONS. The following obligations which are not
15 redeemable at the option of the City:

- 16 (1) Government Obligations; and
- 17 (2) if permitted by law, obligations described in Section 103(a) of
18 the Code, (a) provisions for the payment of the principal of, premium, if any, and interest
19 on which (i) shall have been made by the irrevocable deposit with a bank or trust company
20 acting as a trustee, escrow agent or holder of such obligations, securities described in
21 clause (1) of this definition, the maturing principal of and interest on which, when due and
22 payable, without further investment or reinvestment thereof, will provide sufficient money
23 to pay when due the principal of, premium, if any, and interest on such obligations, and
24 (ii) which securities described in clause (1) of this definition are not available to satisfy
25 any other claim, including any claim of such trustee or escrow agent or of any person
26 claiming through such trustee or escrow agent or to whom such trustee or escrow agent
27 may be obligated, including claims in the event of insolvency of such trustee or escrow
28 agent or proceedings arising out of such insolvency or (b) rated in its highest rating
29 category (without regard to any refinement or gradation thereof by numerical modifier or
30 otherwise) by S&P, Moody's or Fitch.

1 DEPOSITORY. The following registered securities depository: The
2 Depository Trust Company, 570 Washington Boulevard, Jersey City, New Jersey 07310,
3 <http://www.dtcc.com>; or in accordance with then-current guidelines of the United States
4 Securities and Exchange Commission, to such other addresses and/or such other
5 securities depositories, or no such depositories, as an Authorized Officer may designate
6 in a certificate of the City.

7 ELECTRONIC MEANS. Telephone, telecopy, telegraph, facsimile
8 transmission, e-mail or any other similar means of electronic communication. Any
9 communication by telephone as an Electronic Means shall promptly be confirmed in
10 writing, which may be by one of the other means of electronic communication listed in this
11 definition.

12 EMMA. The Municipal Securities Rulemaking Board's Electronic Municipal
13 Market Access System located on its website at emma.msrb.org.

14 EVENT OF DEFAULT. Any of the events set forth in Section 27.

15 EXPENSES. The reasonable and necessary fees, costs and expenses
16 incurred by the City in connection with the issuance of the Series 2024 Bonds and any
17 transaction or event contemplated by the Series 2024 Bonds and the Bond Ordinance
18 including, without limitation: (i) costs of advertising and publication of legislation relating
19 to the Series 2024 Bonds; (ii) costs of printing certificates for the Series 2024 Bonds and
20 any disclosure documents; (iii) legal fees and expenses; (iv) fees and expenses of any
21 (a) fiscal service providers, (b) underwriter (including underwriter's discount), (c) financial
22 advisor, (d) Independent Accountant, (e) escrow agent, and (f) Qualified Counterparty;
23 (v) the initial premium payable to any Insurer with respect to the Series 2024 Bonds; (vi)
24 disclosure matters pertaining or allocable to, the Series 2024 Bonds; and (vii) all
25 reasonable and necessary fees and administrative costs of the City relating to the
26 foregoing.

27 FISCAL AGENT. Collectively, the Paying Agent and Registrar.

28 FISCAL YEAR. The twelve month period beginning on the first day of July
29 of each year and ending on the last day of June of the next succeeding year, or any other
30 twelve month period, which the City or other appropriate authority may establish as the
31 fiscal year for the City.

1 FITCH. Fitch Ratings, its successors and their assigns, and, if such
2 corporation is dissolved or liquidated or no longer performs the function of a securities
3 rating agency, any other nationally recognized securities rating agency designated by the
4 City.

5 GOVERNMENT OBLIGATIONS. Direct obligations of, or obligations the
6 principal of and interest on which are unconditionally guaranteed by, the United States of
7 America or certificates or receipts established by the United States Government or its
8 agencies or instrumentalities representing direct ownership of future interests or principal
9 payments on direct obligations of, or obligations fully guaranteed by, the United States of
10 America or any of its agencies or instrumentalities the obligations of which are backed by
11 the full faith and credit of the United States, which obligations are held by a custodian in
12 safekeeping on behalf of the holders of such receipts, and rated or assessed in its highest
13 Rating Category by S&P, if then rating the Series 2024 Bonds, Moody's, if then rating the
14 Series 2024 Bonds, and Fitch, if then rating the Series 2024 Bonds.

15 GROSS RECEIPTS TAX INCOME FUND. The "City of Albuquerque Gross
16 Receipts Tax Income Fund" continued in Section 15 of the Bond Ordinance.

17 HOME RULE POWERS. The authority of the City to exercise legislative
18 powers given pursuant to the City Charter adopted by the City pursuant to Article X,
19 Section 6 of the State Constitution.

20 INDEPENDENT ACCOUNTANT. Any certified public accountant,
21 registered accountant, or firm of accountants duly licensed to practice and practicing as
22 such under the laws of the State, appointed and paid by the City who (a) is, in fact,
23 independent and not under the domination of the City, (b) does not have any substantial
24 interest, direct or indirect, with the City, and (c) is not connected with the City as an officer
25 or employee of the City, but who may be regularly retained to make annual or similar
26 audits of the books or records of the City.

27 INSURED BANK. Any federally or state-chartered savings and loan
28 association or federally or state-chartered commercial bank, the deposits of which are
29 insured by the Federal Deposit Insurance Corporation and which has, or is the lead bank
30 of a parent holding company which has, combined capital, surplus and undivided profits
31 of not less than \$10,000,000.

1 INSURED OBLIGATIONS. Any Obligations insured by a Bond Insurance
2 Policy or payable with the proceeds of another Credit Facility.

3 INSURER. Any insurer or insurers issuing a Bond Insurance Policy or
4 Surety Bond, or both, for Obligations.

5 INTEREST PAYMENT DATE. January 1 and July 1 of each year (or if such
6 day is not a Business Day, then the next succeeding Business Day), commencing on the
7 date specified in the Sale Certificate.

8 INVESTMENT BANKERS. The purchasers of the Series 2024 Bonds as
9 designated in the Sale Certificate.

10 MATURITY DATE. The date or dates on which the Series 2024 Bonds
11 mature.

12 MOODY'S. Moody's Investors Service, Inc., a corporation organized and
13 existing under the laws of the State of Delaware, its successors and their assigns, and, if
14 such corporation is dissolved or liquidated or no longer performs the functions of a
15 securities rating agency, any other nationally recognized securities rating agency
16 designated by the City.

17 NMSA. New Mexico Statutes Annotated, 1978 Compilation, as amended
18 and supplemented.

19 OFFICIAL STATEMENT. The final disclosure document relating to the sale
20 of the Series 2024 Bonds (including the cover page and all summary statements,
21 appendices and other materials included or incorporated by reference or attached
22 thereto), as amended or supplemented.

23 OUTSTANDING. When used in reference to Tax Obligations, on any
24 particular date, the aggregate of all Tax Obligations issued and delivered under the
25 applicable City ordinance or resolution authorizing the issuance of the Tax Obligations,
26 except:

27 (1) those canceled at or prior to such date or delivered to or
28 acquired by the City at or prior to such date for cancellation;

29 (2) those which have been paid or are deemed to be paid in
30 accordance with the City ordinance or resolution authorizing the issuance of the
31 applicable Tax Obligations, or otherwise relating thereto, provided that the payment of

1 Insured Tax Obligations with the proceeds of a Bond Insurance Policy shall not result in
2 those Insured Tax Obligations ceasing to be Outstanding;

3 (3) in the case of Variable Rate Tax Obligations, any Tax
4 Obligations deemed tendered but not yet presented for payment; and

5 (4) those in lieu of or in exchange or substitution for which other
6 Tax Obligations shall have been delivered, unless proof satisfactory to the City and the
7 Paying Agent for the applicable Tax Obligations is presented that any Tax Obligations for
8 which new Tax Obligations were issued or exchanged are held by a bona fide holder or
9 in due course.

10 OWNER. The registered owner of a Series 2024 Bond as shown, from time
11 to time, on the registration books for the Series 2024 Bonds maintained by the relevant
12 registrar for the City.

13 PAYING AGENT. The City Treasurer or other agent for the City for the
14 payment of the Series 2024 Bonds and any co-paying agent or successor paying agent
15 which is a trust company, national or state banking association or financial institution
16 appointed by resolution of the Council or by an Authorized Officer from time to time.

17 PAYMENT OBLIGATIONS. All obligations of the City to pay the Credit
18 Source the principal amount of, interest on, and fees, costs, expenses and other amounts
19 related to drawings, term loans and other advances and Obligations held by that Credit
20 Source, pursuant to that Credit Facility.

21 PERMITTED INVESTMENTS. Any investment legally permitted pursuant
22 to Section 6-10-10 NMSA 1978, the City Charter and the City Investment Policy.

23 PERSON. Any individual, corporation, partnership (in which case each
24 partner shall be deemed a Person), joint venture, association, joint stock company, limited
25 liability company, trust, unincorporated organization, or government or any agency or
26 political subdivision of a government.

27 PLEDGED REVENUES. The State-Shared Gross Receipts Tax Revenues.

28 PRELIMINARY OFFICIAL STATEMENT. The initial disclosure document
29 relating to the sale of the Series 2024 Bonds (including the cover page and all summary
30 statements, appendices and other materials included or incorporated by reference or
31 attached thereto), as amended or supplemented.

19 term rating category by a numerical modifier or otherwise.

20 RECORD DATE. The fifteenth day of the month immediately preceding
21 each Interest Payment Date.

22 REGISTRAR. The Treasurer or other agent for the City for the transfer and
23 exchange of the Series 2024 Bonds and any co-registrar or successor registrar which is
24 a trust company, national or state banking association or financial institution appointed by
25 resolution of the Council or by an Authorized Officer from time to time.

26 RELATED DOCUMENTS. The Bond Purchase Agreement, the Continuing
27 Disclosure Undertaking, and any other documents relating to the Series 2024 Bonds
28 identified and approved in the Bond Ordinance.

29 RESERVE FUND INSURANCE POLICY. Any policy of insurance or surety
30 bond or other Credit Facility issued to the City to be deposited in a reserve account, the
31 proceeds of which shall be used to prevent deficiencies in the payment of the principal of

8 from the State gross receipts tax derived pursuant to Section 7-9-4 NMSA 1978, imposed
9 on persons engaging in business in the State, which revenues are remitted monthly by
10 the Revenue Division of the Taxation and Revenue Department of the State to the City
11 as authorized by Sections 7-1-6.1 and 7-1-6.4 NMSA 1978, and which remittances as of
12 the date of adoption of this Bond Ordinance are equal to one and two hundred twenty-
13 five thousandths percent (1.225%) of the taxable gross receipts reported to the City for
14 the month for which such remittance is made; provided that if a greater amount of such
15 gross receipts tax revenues are hereafter provided to be remitted to the City under
16 applicable law, such additional amounts shall be included as revenues pledged pursuant
17 to the Bond Ordinance; and provided further that the amount of revenues pledged

5 SURETY BOND. Any policy of insurance or surety bond with respect to a

8 satisfy, in whole or in part, the reserve requirement for that series or to replace any money
9 on deposit in a debt service reserve account or similar account.

10 TAX OBLIGATIONS. Senior Tax Obligations and any other bonds, notes
11 or other instruments which evidence a borrowing payable from and secured by the State-
12 Shared Gross Receipts Tax Revenues, now Outstanding or hereafter issued or incurred.

13 VARIABLE INTEREST RATE. An interest rate which varies or fluctuates
14 from time to time. Except for any historical period for which the actual rate or rates are
15 determinable, and unless otherwise stated in the Bond Ordinance, interest shall be
16 calculated for Variable Interest Rate Tax Obligations at the maximum interest rate then
17 permitted on such Tax Obligations by the City ordinance authorizing the issuance of such
18 Tax Obligations.

19 VARIABLE RATE OBLIGATIONS. Tax Obligations, including
20 reimbursement obligations pursuant to a Credit Facility, the interest rate on which is
21 subject to change from time to time.

22 (B) RULES OF CONSTRUCTION. For purposes of the Bond Ordinance,
23 unless otherwise expressly provided or unless the context require otherwise:

24 (1) Unless otherwise stated in the Bond Ordinance, all references
25 in the Bond Ordinance to designated Sections and other subdivisions are to the

10 SECTION 2. RATIFICATION. All actions previously taken (not inconsistent with
11 the provisions of the Bond Ordinance) by the Council and the officers of the City, directed
12 toward (1) the Project and (2) the issuance and sale of the Series 2024 Bonds are ratified,
13 approved and confirmed.

14 SECTION 3. FINDINGS. The Council declares that it has considered all relevant
15 information and data and makes the following findings:

16 (A) The Pledged Revenues may lawfully be pledged to secure the Series
17 2024 Bonds to the extent and in the manner provided in the Bond Ordinance.

18 (B) The Series 2024 Bonds will be issued pursuant to the Act.

19 (C) It is economically feasible to accomplish the Project by the issuance
20 of the Series 2024 Bonds.

21 (D) The issuance of the Series 2024 Bonds and the design,
22 development, construction, reconstruction, rehabilitation, renovation, modernization,
23 signage, enhancement and other improvement of the Project are in the interest of the
24 public health, safety and welfare of the residents of the City.

25 (E) The exact principal amounts of the Series 2024 Bonds, the interest
26 rates and sale prices of the Series 2024 Bonds will be established in the Sale Certificate,
27 but in no event shall the net effective interest rate on the Series 2024 Bonds exceed
28 twelve percent (12%) per annum as required by Section 6-14-3 NMSA 1978.

29 SECTION 4. AUTHORIZATIONS.

30 (A) AUTHORIZATION OF SERIES 2024 BONDS AND PROCEEDS OF
31 SERIES 2024 BONDS. This Bond Ordinance has been adopted by the affirmative vote

1 of at least three-quarters of the members of the Council. For the purpose of protecting
2 the public health, conserving the property, protecting the general welfare and prosperity
3 of the residents of the City, it is declared necessary that the City issue its negotiable, fully
4 registered Series 2024 Bonds pursuant to the Act, as set forth in this Bond Ordinance.
5 The Series 2024 Bonds are designated as the "City of Albuquerque, New Mexico Gross
6 Receipts Tax Improvement Revenue Bonds, Series 2024," provided that changes may
7 be made in the designation to better identify the Series 2024 Bonds. The issuance of the
8 Series 2024 Bonds in one or more series on a taxable or tax-exempt basis and in an
9 aggregate principal amount not to exceed \$22,500,000 is authorized and approved. The
10 negotiated sale of the Series 2024 Bonds to the Investment Bankers shall be approved
11 in the Sale Certificate and Bond Purchase Agreement. The underwriter's discount on the
12 Bonds shall not exceed 3% of the aggregate principal amount of the Bonds. The final
13 maturity of the Series 2024 Bonds shall be no later than July 1, 2049.

14 (B) PROJECT. The Project is authorized and approved. The Project will
15 include the design, development, construction, reconstruction, rehabilitation, renovation,
16 modernization, signage, enhancement and other improvement of certain capital
17 improvements, including the Southwest Public Safety Center, City youth shelters, Cibola
18 Loop Multigenerational Center, Gibson Health Hub, Westside Emergency Housing
19 Shelter, the Albuquerque Railyards, and the acquisition of a law enforcement helicopter.

20 In accordance with United States Treasury Regulation Section 1.150-2, the
21 City presently intends and reasonable expects to reimburse itself with all or a portion of
22 the proceeds of the Series 2024 Bonds for capital expenditures on the Project initially
23 financed or to be financed with legally available funds of the City. All of the capital
24 expenditures covered by this paragraph were or will be made on or after the date that is
25 60 days prior to the effective date of this Ordinance.

26 (C) EXPENSES. The payment of Expenses is authorized and approved.

27 SECTION 5. SERIES 2024 BONDS.

28 (A) DETAILS. The Series 2024 Bonds shall be issued in an aggregate
29 principal amount not to exceed \$22,500,000, and shall be dated the initial date of delivery
30 to the Investment Bankers. The Series 2024 Bonds shall be issued as fully registered
31 bonds and shall be numbered with such prefixes or other distinguishing designations as

1 the Registrar may determine necessary or appropriate to distinguish one Series 2024
2 Bond from another. The Series 2024 Bonds shall be issued in Authorized Denominations

4 most recent date to which interest has been paid or provided for or, if no interest has been
5 paid or provided for, from their date until maturity or prior redemption, payable
6 semiannually on January 1 and July 1 of each year in the years, amounts and interest
7 rates as set forth in the Sale Certificate.

8 The net effective interest rate on the Series 2024 Bonds shall not exceed
9 twelve percent (12%).

10 (B) PAYMENT OF SERIES 2024 BONDS; TRANSFERS TO PAYING
11 AGENT. Payments on the Series 2024 Bonds shall be made in such coin or currency of
12 the United States of America as, at the respective times of payment, is legal tender for
13 the payment of public and private debts. The City shall transfer funds to the Paying Agent
14 for the Series 2024 Bonds on a timely basis so that the Paying Agent may make payments
15 of the principal of, premium, if any, and interest on Series 2024 Bonds, when due, to the
16 Owners and comply with the requirements of any Insurer relating to payments of Series
17 2024 Bonds. As soon as known to the City, the City shall notify the Paying Agent if there
18 is or will be an insufficient amount of money available to pay principal and interest on the
19 Series 2024 Bonds when due.

20 The principal of and premium, if any, on the Series 2024 Bonds shall be
21 payable to the Owners upon presentation and surrender of their Series 2024 Bonds at
22 the principal office of the Paying Agent.

23 Interest on the Series 2024 Bonds shall be payable on each Interest
24 Payment Date by the Paying Agent by check mailed on the date on which due to the
25 Owners at the close of business on the Record Date for such Interest Payment Date to
26 the registered addresses of Owners appearing on the registration books for the Series
27 2024 Bonds. In the case of any Owner of Series 2024 Bonds in an aggregate principal
28 amount in excess of \$1,000,000 as shown on the registration books who, prior to the
29 Record Date for the Series 2024 Bonds next preceding any Interest Payment Date, has
30 provided the Paying Agent with wire transfer instructions, interest shall be paid in

1 immediately available funds in accordance with the wire transfer instructions provided by
2 that Owner.

3 If and to the extent that the City fails to make payment or provision for
4 payment of interest on any Series 2024 Bond on any Interest Payment Date, interest shall
5 continue to accrue on that Series 2024 Bond but shall cease to be payable to the Owner
6 of that Series 2024 Bond as of the applicable Record Date. When money becomes
7 available for payment of the interest, (i) the Registrar shall establish a Special Record
8 Date for the payment of that interest which shall be not more than 15 nor fewer than 10
9 days prior to the date of the proposed payment, and (ii) the Registrar shall give notice by
10 first-class mail of the proposed payment and of the Special Record Date to each Owner
11 not less than 10 days prior to the Special Record Date and, thereafter, the interest shall
12 be payable to the Owners at the close of business on the Special Record Date.

13 While a Depository or its nominee is the owner of the Series 2024 Bonds,
14 principal and interest payments on the Series 2024 Bonds shall be made to the
15 Depository, or its nominee, as required by the Depository.

16 (C) BOOK-ENTRY. The Series 2024 Bonds shall initially be issued or
17 registered in book-entry form, from time to time, with a Depository acting as securities
18 depository for the Series 2024 Bonds with no physical distribution of bond certificates
19 made to the public. A single certificate for each maturity date of each of the Series 2024
20 Bonds issued in book-entry form shall be delivered to such Depository and immobilized
21 in its custody. The book-entry system shall evidence ownership of Series 2024 Bonds in
22 Authorized Denominations, with transfer of ownership effected on the books of the
23 Depository and its participants ("Participants"). As a condition to delivery of Series 2024
24 Bonds in book-entry form, the purchaser of the Series 2024 Bonds shall, immediately
25 after acceptance of delivery thereof, deposit those Series 2024 Bonds certificates with
26 such Depository, registered in the name of such Depository or its nominee. Principal,
27 premium, if any, and interest will be paid to such Depository or its nominee as the
28 registered Owner of those Series 2024 Bonds. The transfer of principal and interest
29 payments to Participants shall be the responsibility of such Depository; the transfer of
30 principal and interest payments to the beneficial owners of Series 2024 Bonds (the
31 "Beneficial Owners") shall be the responsibility of such Participants and other nominees

5 If (i) the Series 2024 Bonds are not eligible for the services of the institution
6 which has been acting as the Depository for the Series 2024 Bonds, (ii) the institution that
7 has been acting as the Depository determines to discontinue its services with respect to
8 the Series 2024 Bonds or (iii) the City determines that a continuation of the system of
9 book-entry transfers through the institution that has been acting as the Depository ceases
10 to be beneficial to the City or the Beneficial Owners, the City shall either identify another
11 Depository or certificates shall be delivered to Beneficial Owners or their nominees. In
12 the event of the discontinuation of the book-entry system for the Series 2024 Bonds, the
13 Beneficial Owners or their nominees, upon authentication of the Series 2024 Bonds and
14 registration of the Series 2024 Bonds in the Beneficial Owners’ or nominees’ names, shall
15 become the Owners for all purposes. The City shall mail an appropriate notice to the
16 Depository for notification to Participants, Indirect Participants and Beneficial Owners of
17 the substitute Depository or the issuance of bond certificates to Beneficial Owners or their
18 nominees, as applicable.

19 Notwithstanding any other provision of the Bond Ordinance to the contrary,
20 as long as all Series 2024 Bonds are registered in the name of a Depository or its
21 nominee, all payments with respect to principal of, redemption premium, if any, and
22 interest on those Series 2024 Bonds, and all notices with respect to those Series 2024
23 Bonds, shall be made and given by the Paying Agent or the City to the Depository, by the
24 Depository to its Participants or Indirect Participants and by the Participants and Indirect
25 Participants to the Beneficial Owners.

26 (D) SERIES 2024 BONDS NOT PRESENTED FOR PAYMENT. If any
27 Series 2024 Bonds are not presented for payment when the principal becomes due either
28 at maturity or at the date fixed for redemption thereof or otherwise, or if any check or draft
29 mailed to an Owner in connection with a payment of interest on any Series 2024 Bonds
30 is not cashed by an Owner, and an amount sufficient to pay those Series 2024 Bonds or
31 interest is held by the Paying Agent for the benefit of the Owners, the Paying Agent shall

6 Any money which the Paying Agent segregates and holds in trust for the
7 payment of the principal of, premium or interest on Series 2024 Bonds which remains
8 unclaimed for three years after such payment has become due shall be paid to the City.
9 After the payment of such unclaimed money to the City, the Owners shall look only to the
10 City for the payment of those Series 2024 Bonds.

11 SECTION 6. REDEMPTION OF SERIES 2020 BONDS.

12 (A) OPTIONAL REDEMPTION. All or any portion of the Series 2024
13 Bonds may be subject to optional redemption prior to their stated maturities at a
14 redemption price and on the dates established therefor in the Sale Certificate.

15 If subject to optional redemption, unless money sufficient to pay the
16 principal of and premium, if any, on the Series 2024 Bonds to be redeemed pursuant to
17 this Section 6.(A) is received by the Paying Agent prior to the giving of notice of
18 redemption in accordance with Section 6.(D), that notice shall state that the redemption
19 is conditional upon the receipt of that money by the Paying Agent by 2:00 p.m., prevailing
20 Mountain Time, on the redemption date. If an amount sufficient to redeem all Series 2024
21 Bonds called for redemption is not received by that time (i) the Paying Agent shall redeem
22 only those Series 2024 Bonds for which the redemption price was received, (ii) the Series

24 and (iii) the redemption notice shall have no effect with respect to those Series 2024

12 name of the transferee or Owner a new Series 2024 Bond or Bonds of the same series
13 and Maturity Date, interest rate and same aggregate principal amount in Authorized
14 Denominations.

15 (B) OWNER OF BONDS. The person in whose name any Series 2024
16 Bond is registered shall be deemed and regarded as its absolute Owner for all purposes,
17 except as may otherwise be provided with respect to the payment of interest on Series
18 2024 Bonds in Section 5.(C). Payment of the principal on any Series 2024 Bonds shall
19 be made only to or upon the order of its Owner or his legal representative. All such
20 payments shall be valid and effectual to satisfy and discharge the liability on Series 2024
21 Bonds to the extent of the amount paid.

22 (C) REPLACEMENT OF BONDS. If any Series 2024 Bond is lost,
23 stolen, destroyed or mutilated, the Registrar shall, upon receipt of that Series 2024 Bond
24 if mutilated, and evidence, information or indemnity which the Registrar may reasonably
25 require, authenticate and deliver a replacement Series 2024 Bond or Bonds of the same
26 aggregate principal amount, series and Maturity Date and interest rate, bearing a number
27 or numbers not then outstanding. If any lost, stolen, destroyed or mutilated Series 2024
28 Bond has matured or been called for redemption, the Registrar may direct the Paying
29 Agent to pay that Series 2024 Bond in lieu of replacement.

30 (D) CHARGES. Exchanges and transfers of Series 2024 Bonds shall be
31 made without charge to the Owners or any transferee except that the Registrar may make

8 authorized to deliver to the Registrar fully registered but unauthenticated Series 2024
9 Bonds in such quantities as may be convenient to be held in custody by the Registrar
10 pending the use thereof as provided in the Bond Ordinance.

11 SECTION 8. NEGOTIABILITY. Series 2024 Bonds shall be fully negotiable and
12 shall have all the qualities of negotiable paper, and the owner or owners thereof shall
13 possess all rights enjoyed by the owners of negotiable instruments under the provisions
14 of the Uniform Commercial Code—Investment Securities in effect in the State.

15 SECTION 9. SPECIAL LIMITED OBLIGATIONS. The Series 2024 Bonds, and all
16 payments of principal, premium, if any, and interest thereon (whether at maturity or on a
17 redemption date), and the obligations of the City for all other payments, fees, costs,
18 interest and expenses under the Bond Ordinance and under all Related Documents shall
19 be special limited obligations of the City payable solely from State-Shared Gross Receipts
20 Tax Revenues, which Pledged Revenues are pledged and are payable as set forth in
21 Sections 18 and 19. However, the Series 2024 Bonds are also payable from amounts on
22 deposit in the Series 2024 Debt Service Fund and the Series 2024
23 Acquisition/Construction Fund.

24 Owners and the parties under any Related Documents may not look to any general
25 or other fund of the City for the payment of the principal of or interest on, or the fees, costs
26 and expenses relating to, such obligations, except the designated special funds pledged
27 therefor. Neither the Series 2024 Bonds nor the obligations of the City under any Related
28 Documents shall constitute an indebtedness of the City within the meaning of any
29 constitutional, charter or statutory prohibition or limitation, nor shall they be considered or
30 held to be general obligations of the City, and the Series 2024 Bonds shall recite that they
31 are payable and collectable solely out of Pledged Revenues and from any other sources

5 SECTION 10. EXECUTION AND CUSTODY OF SERIES 2024 BONDS.

6 (A) FILING MANUAL SIGNATURES. Prior to the execution of any
7 Series 2024 Bonds pursuant to Sections 6-9-1 through 6-9-6 NMSA, the Mayor, City Clerk
8 and City Treasurer may each file with the Secretary of State of New Mexico his or her
9 manual signature certified by him or her under oath; provided that such filing shall not be
10 necessary for any officer where any previous filing may have legal application or if the
11 Bonds are signed manually.

12 (B) EXECUTION. Series 2024 Bonds shall be signed with the manual
13 or facsimile signature of the Mayor and the manual or facsimile signature of the City
14 Treasurer or City Clerk. There shall be placed on each Series 2024 Bond the printed,
15 engraved, stamped or otherwise placed facsimile or imprint of the City's corporate seal.
16 Series 2024 Bonds when authenticated and bearing the manual or facsimile signatures
17 of the officers in office at the time of their signing shall be valid and binding obligations of
18 the City, notwithstanding that before delivery of those Series 2024 Bonds, any or all of
19 the persons who executed those Series 2024 Bonds shall have ceased to fill their
20 respective offices. The Mayor, City Clerk and City Treasurer, at the time of the execution
21 of the Series 2024 Bonds, each may adopt as and for his or her own facsimile signature
22 the facsimile signature of his or her predecessor in office if such facsimile signature
23 appears upon any of the Series 2024 Bonds or certificates pertaining to the Series 2024
24 Bonds.

25 (C) CUSTODY. The Registrar shall hold in custody all Series 2024

30 (D) AUTHENTICATION. No Series 2024 Bonds shall be valid or

8 SECTION 12. SUCCESSOR REGISTRAR OR PAYING AGENT. If the Registrar
9 or Paying Agent initially appointed shall resign, or if the City shall determine to appoint a
10 successor or co-Registrar or co-Paying Agent or shall reasonably determine that a
11 Registrar or Paying Agent has become incapable of fulfilling its duties under the Bond
12 Ordinance, the City may, upon notice mailed to each Owner at the address last shown on
13 the registration books, appoint a successor or co-Registrar or Paying Agent. Every such
14 successor or co-Registrar or Paying Agent shall be a bank or trust company located and
15 in good standing in the United States with a capital stock, surplus and undivided profits,
16 however denominated, of not less than \$75,000,000 or the City Treasurer, or any
17 successor in office. Notwithstanding any other provision of the Bond Ordinance, no
18 removal, resignation or termination of the Paying Agent shall take effect until a successor
19 shall be appointed. Additional provisions relating to the Registrar and the Paying Agent
20 and the payment of the Series 2024 Bonds may be in a separate paying agent agreement
21 executed on behalf of the City by an Authorized Officer.

27 the Project has been completed. As soon as practicable, and in any event not more than
28 60 days after the Completion Date, any balance remaining in the applicable account of

16 Income Fund and shall be concurrently credited to the Series 2024 Debt Service Fund
17 (only if amounts described in paragraph (1) herein are insufficient to pay the Debt Service
18 Requirements for the Series 2024 Bonds) or any relevant debt service account, with the
19 same priority and, if insufficient to pay all of the enumerated Debt Service Requirements,
20 pro rated in proportion to the amounts of such Debt Service Requirements (monthly, in
21 the case of the Series 2024 Bonds, in accordance with Section 19.(G)):

22 (a) Prior to each interest payment date, that amount
23 necessary to pay or reimburse the next maturing installment of interest on each series of
24 Senior Tax Obligations then Outstanding.

25 (b) Prior to each principal payment date, that amount
26 necessary to pay the next regularly scheduled installment of principal, whether at maturity
27 or a mandatory sinking fund redemption date, of each series of Senior Tax Obligations
28 then Outstanding.

29 (c) Prior to their respective due dates, the amounts
30 necessary to pay or reimburse the provider of a Credit Facility for payments of Debt
31 Service Requirements (but not tender price) on Senior Tax Obligations made by that

1 Credit Source. The tender price of a series of Senior Tax Obligations and any interest

5 but shall be reimbursed with the priority set forth in Section 18.(C).

6 (2) The City may pay the Debt Service Requirements on the
7 Series 2024 Bonds and, unless otherwise required under the ordinance or resolution
8 under which they were issued, any other Senior Tax Obligations from Pledged Revenues
9 as described in Sections 18.(B)(1) and 18.(B)(2) in such order, in whole or in part, as to
10 the use of State-Shared Gross Receipts Tax Revenues as the City may from time to time
11 determine in its sole discretion.

12 (C) OTHER TAX OBLIGATIONS. To the extent not required to be
13 deposited or paid pursuant to Sections 18.(A) or 18.(B), State-Shared Gross Receipts
14 Tax Revenues available in the Gross Receipts Tax Income Fund shall be used, as
15 necessary, to pay (x) payment obligations owed by the City to the Credit Source for Senior
16 Tax Obligations, including the tender price of and certain interest payments on, Senior
17 Tax Obligations paid by that Credit Source; and (y) fees, expenses and interest owed by
18 the City to any other provider of fiscal services for a series of Senior Tax Obligations.
19 Amounts from the Gross Receipts Tax Income Fund to be used to pay interest pursuant
20 to this Section 18.(C) shall be deposited by the City into a separate account maintained
21 by the City on or before the due date thereof.

22 (D) DEBT SERVICE RESERVE REQUIREMENTS. To the extent not
23 required to be deposited or paid pursuant to Sections 18.(A), 18.(B) or 18.(C), State-

30 be used, as necessary, to pay Debt Service Requirements on Subordinate Gross
31 Receipts Tax Obligations as the same accrue.

11 (1) MONEY IN DEBT SERVICE FUNDS. Except as provided in
12 Section 19.(A)(2), the money credited to the Series 2024 Debt Service Fund shall be used
13 by the City only to pay, or to reimburse a Credit Source for the payment of, the Debt
14 Service Requirements of the Series 2024 Bonds. Money on deposit in the Series 2024
15 Debt Service Fund shall be transferred to the Paying Agent on or before each relevant
16 payment date.

17 (2) TERMINATION UPON DEPOSITS TO MATURITY. No
18 payment needs to be made into the Series 2024 Debt Service Fund or any debt service
19 reserve fund for the Series 2024 Bonds, if no Debt Service Requirements on the Series
20 2024 Bonds are then past due and the amounts on deposit in the Series 2024 Debt
21 Service Fund for the payment of such Series 2024 Bonds are at least equal to all Debt
22 Service Requirements on such Series 2024 Bonds to their Maturity Dates or mandatory
23 redemption dates, or to any date for which the City has exercised or has obligated itself
24 to exercise its option to redeem such Series 2024 Bonds prior to their Maturity Dates or
25 redemption dates. In such event, money in the Series 2024 Debt Service Fund shall be
26 used for the payment of the Debt Service Requirements or such optional redemption
27 payments, if applicable, when due, on the respective Series 2024 Bonds. Any money in
28 those accounts in excess of the amounts required by the preceding sentence may be
29 used as provided in Section 18.(D).

30 (B) CREDIT OR DEFICIENCY. In making the determinations of the
31 amounts to be transferred from the Gross Receipts Tax Income Fund as provided in

5 pay or credit to that fund from Pledged Revenues in the Gross Receipts Tax Income Fund
6 to the respective Series 2024 Bonds, the first money available to pay that deficiency using
7 the priorities set forth in Section 18 and this Section 19.

8 (C) TRANSFER OF MONEY. Each payment of principal and interest
9 coming due on the Series 2024 Bonds shall be transferred from the applicable fund to the
10 Paying Agent.

11 (D) VARIABLE INTEREST RATE. In making the computations required
12 by Section 18 and this Section 19, interest on Variable Interest Rate Tax Obligations
13 which cannot be computed exactly shall be computed at the maximum interest rate
14 permitted for those Tax Obligations unless otherwise required by the City ordinance
15 authorizing the issuance of such Tax Obligations.

16 (E) INVESTMENT OF MONEY. Any money in any fund created or
17 continued in Section 15 shall be invested in Permitted Investments. The investments
18 purchased using money in any such fund shall be deemed at all times to be part of that
19 fund. The interest accruing in the funds and any profit realized therefrom shall be credited
20 to the fund in which the relevant investments are deemed to be held. Any loss resulting
21 from such investment shall be charged to the applicable fund. The City Treasurer shall
22 present for redemption or sale on the prevailing market any obligations purchased as an
23 investment of money in the applicable fund whenever it shall be necessary to do so in
24 order to provide money to meet any payment or transfer from such fund. Neither the City
25 Treasurer nor any other officer of the City shall be liable or responsible for any loss
26 resulting from any such investment made in accordance with the Bond Ordinance.

27 (F) DEPOSITS OF FUNDS. The money and investments deposited in
28 the funds created or continued in Section 15 shall be maintained and kept in one or more
29 Insured Banks. Each payment shall be made into and credited to the proper fund at the
30 designated time, except that when the designated time is not a Business Day, then such
31 payment shall be made on the next succeeding Business Day. Nothing herein shall

1 prevent the establishment of one or more such funds in insured banks for all of the
2 accounts designated in Section 15.

3 (G) DEPOSITS OF PLEDGED REVENUES FOR SERIES 2024
4 BONDS.

5 (1) The City shall make substantially equal monthly deposits into
6 each of the Series 2024 Debt Service Fund as required in order to pay the amount of
7 interest on the Series 2024 Bonds, which will become due on the Interest Payment Date
8 next following the date of deposit. The monthly deposits required in the preceding
9 sentence shall begin in the calendar month subsequent to the Closing Date.

10 (2) Deposits to the Series 2024 Debt Service Fund for the next
11 installments of principal becoming due on the Series 2024 Bonds shall be made in
12 substantially equal monthly deposits commencing in the first month which is less than 13
13 months prior to the month in which that installment of principal is due.

14 Deposits for the payment of principal of and interest on the other Senior Tax
15 Obligations required by Section 18.(B) may be made more or less frequently than
16 monthly.

17 (H) VALUATION. The "value" of Permitted Investments shall be
18 determined at least every six months as follows:

19 (1) if the price of the investment is not set as described in Section
20 19(H)(4), as to investments the bid and asked prices of which are published on a regular
21 basis in The Wall Street Journal (or, if not there, then in The New York Times): the
22 average of the bid and asked prices for such investments published on or more recently
23 prior to such time of determination;

24 (2) as to investments the bid and asked prices of which are not
25 published on a regular basis in The Wall Street Journal or The New York Times: the
26 average bid price at such time of determination for such investments by any two nationally
27 recognized government securities dealers (selected by the City in its absolute discretion)
28 at the time making a market in such investments or the bid price published by a nationally
29 recognized pricing service;

30 (3) as to certificates of deposit and bankers acceptances: the
31 face amount thereof, plus accrued interest;

5 agreement, shall be rated in one of the top two Rating Categories by S&P, Moody's and
6 Fitch if then rating the Series 2024 Bonds, or by another national rating agency; and

7 (5) as to any investment not specified above: the cost of the
8 Permitted Investments (including any amount paid as accrued interest) or the principal
9 amount thereof, whichever is less; except that Permitted Investments purchased at a
10 premium may initially be valued at the cost thereof, but in each year after such purchase
11 shall be valued at a lesser amount determined by ratably amortizing the premium over
12 the remaining term.

13 No loss or profit on Permitted Investments shall be deemed to take place
14 as a result of fluctuations in the market quotations prior to the sale or maturity thereof.

15 SECTION 20. LIEN ON PLEDGED REVENUES; PROCEEDS; ETC.

16 (A) SERIES 2024 BONDS. Payments of Debt Service Requirements on
17 the Series 2024 Bonds are secured by an irrevocable lien on, and the City grants and
18 confirms to the owners of the Series 2024 Bonds a security interest in, the State-Shared
19 Gross Receipts Tax Revenues for the payment of the principal of and interest on the
20 Series 2024 Bonds. The Series 2024 Bonds shall be issued as Senior Tax Obligations.

21 The City pledges and grants a security interest in and lien (but not an
22 exclusive lien) on the money and Permitted Investments on deposit in the Series 2024
23 Debt Service Fund, the Series 2024 Acquisition/Construction Fund and any other fund for
24 the respective Series 2024 Bonds held pursuant to the Bond Ordinance for the Series
25 2024 Bonds.

26 (B) OTHER RELATED DOCUMENTS. Payments under any other
27 Related Documents shall be secured by an irrevocable lien on, and the City grants to the
28 parties entitled to payments under those Related Documents a security interest in, the
29 Pledged Revenues for those payments.

5 Ordinance, the Series 2024 Bonds from time to time Outstanding shall not be entitled to
6 any priority one over the other, within each series, in the application of the respective
7 Pledged Revenues, regardless of the time or times of their issuance, it being the intention
8 of the Council that there shall be no priority among the Series 2024 Bonds, within each
9 series, regardless of the fact that they may be actually issued and delivered at different
10 times.

11 SECTION 22. ADDITIONAL BONDS OR OTHER OBLIGATIONS PAYABLE
12 FROM STATE-SHARED GROSS RECEIPTS TAX REVENUES.

13 (A) LIMITATIONS UPON ISSUANCE OF ADDITIONAL SENIOR TAX
14 OBLIGATIONS. No provision of the Bond Ordinance shall be construed in such a manner
15 as to prevent the issuance of additional Senior Tax Obligations or to prevent the issuance
16 of Tax Obligations refunding all or a part of a series of Senior Tax Obligations. However,
17 before additional Senior Tax Obligations are issued:

18 (1) The City shall then be current in the accumulations required
19 to be made pursuant to any ordinance or resolution authorizing the issuance of any Senior
20 Tax Obligations; and

21 (2) With respect to additional Senior Tax Obligations:

22 (a) The State-Shared Gross Receipts Tax Revenues
23 received by the City for either (i) the Fiscal Year or (ii) any twelve consecutive months out
24 of the eighteen calendar months immediately preceding the date of the issuance of such
25 additional Senior Tax Obligations, shall have been sufficient to pay an amount
26 representing two hundred and twenty-five percent (225%) of the combined maximum
27 annual principal and interest payments (excluding any reserves therefor) coming due in
28 any subsequent Fiscal Year on: (i) the then Outstanding Senior Tax Obligations, and (ii)
29 the Senior Tax Obligations proposed to be issued.

30 (b) A written certificate or opinion by an Independent
31 Accountant or an Authorized Officer that such annual State-Shared Gross Receipts Tax

1 Revenues are sufficient to pay the amounts required by paragraph (a) above shall be
2 conclusively presumed to be accurate in determining the right of the City to authorize,
3 issue, sell and deliver the proposed additional Senior Tax Obligations.

4 (c) In making the computations required by this Section
5 22.(A)(2) and Section 23.(B), that part of the interest rate on Variable Rate Gross Receipts
6 Tax Obligations which cannot be computed exactly shall be computed at the maximum
7 interest rate then permitted on such obligations by the City ordinance authorizing the
8 issuance of such obligations.

9 (B) SUBORDINATE TAX OBLIGATIONS PERMITTED. No provision of
10 the Bond Ordinance shall be construed to prevent the issuance by the City of Subordinate
11 Gross Receipts Tax Obligations.

12 (C) SUPERIOR TAX OBLIGATIONS PROHIBITED. No provision of the
13 Bond Ordinance shall be construed to permit the City to issue, and the City shall not issue,
14 obligations payable from the State-Shared Gross Receipts Tax Revenues having a lien
15 thereon prior and superior to the Senior Tax Obligations.

16 SECTION 23. REFUNDING BONDS PAYABLE FROM STATE-SHARED
17 GROSS RECEIPTS TAX REVENUES. The provisions of Section 22 are subject to the
18 following exceptions:

19 (A) PRIVILEGE OF ISSUING REFUNDING TAX OBLIGATIONS.
20 Outstanding Tax Obligations may be refunded, regardless of whether the priority of the
21 lien for the payment of the refunding obligations on the State-Shared Gross Receipts Tax
22 Revenues is different than the lien of the refunded Tax Obligations on State-Shared Gross
23 Receipts Tax Revenues, except as provided in Section 22.(C) and in Sections 23.(B),
24 23.(C) and 23.(D).

25 (B) LIMITATIONS UPON ISSUANCE OF REFUNDING GROSS TAX
26 OBLIGATIONS. No refunding Gross Receipts Tax Obligations shall be issued as Senior
27 Tax Obligations unless:

28 (1) The Tax Obligations refunded are Senior Tax Obligations and
29 the issuance of the refunding Tax Obligations does not increase the maximum annual
30 Debt Service Requirements of the refunded Tax Obligations and all other Outstanding
31 Tax Obligations on the refunding date; or

1 (2) The refunding Senior Tax Obligations are issued in
2 compliance with Section 22.(A).

3 (C) REFUNDING PART OF A SERIES. While the Series 2024 Bonds
4 are Outstanding, except as set forth in subparagraph (3) below, the refunding Tax
5 Obligations shall enjoy complete equality of lien on the State-Shared Gross Receipts Tax
6 Revenues with the portion of any Tax Obligations of the same series which is not refunded
7 and the Owners of the refunding Tax Obligations shall be subrogated to all of the rights
8 and privileges enjoyed by the Owners of the refunded Tax Obligations.

9 A part of a series of Outstanding Tax Obligations may be refunded only with
10 the consent of the Owners of the unrefunded portion of that series unless:

11 (1) The issuance of the refunding Tax Obligations does not
12 increase the maximum annual Debt Service Requirements evidenced by the refunded
13 Tax Obligations and by the Outstanding Tax Obligations of such series not refunded on
14 the refunding date; or

15 (2) The refunding Senior Tax Obligations are issued in
16 compliance with Section 22.(A); or

17 (3) The lien on the State-Shared Gross Receipts Tax Revenues
18 for the payment of the refunding Tax Obligations is subordinate to the lien thereon for the
19 payment of the unrefunded portion of the series.

20 (D) LIMITATIONS UPON ISSUANCE OF REFUNDING TAX
21 OBLIGATIONS. Any refunding Tax Obligations shall be issued with such details as the
22 City may provide by ordinance and resolution, but without any impairment of any
23 contractual obligations imposed upon the City by any proceedings authorizing the
24 issuance of any Outstanding Tax Obligations.

25 SECTION 24. PROTECTIVE COVENANTS. The City covenants and agrees, so
26 long as any Series 2024 Bonds remain Outstanding:

27 (A) USE OF PROCEEDS OF TAX OBLIGATIONS. The City shall
28 proceed without delay to apply the proceeds of the Series 2024 Bonds to the purposes
29 for which they are issued.

30 (B) PAYMENT OF OBLIGATIONS. The City shall promptly pay Debt
31 Service Requirements on each series of Tax Obligations at the place, on the date and in

1 the manner specified in the City ordinances and resolutions and the documents relating
2 to those Tax Obligations.

3 (C) CITY'S EXISTENCE. The City shall maintain its corporate identity
4 and existence unless another political subdivision by operation of law succeeds to the
5 liabilities and rights of the City under the Bond Ordinance, without adversely affecting to
6 any substantial degree the privileges and rights of any Owner.

7 (D) PROHIBITION OF ANY EXTENSION OF INTEREST PAYMENTS.
8 In order to prevent any accumulation of claims for interest after maturity, the City shall not
9 directly or indirectly extend or assent to the extension of time for the payment of any claim
10 for interest on any Series 2024 Bonds. If the time for payment of any interest is extended,
11 such payment shall not be made by the City, in case of default under the Bond Ordinance,
12 until the prior payment in full of the Debt Service Requirements on all Series 2024 Bonds
13 on which the payment of interest has not been extended.

14 (E) RECORDS. The City shall keep proper books of record and account,
15 separate and apart from all other records and accounts, showing complete and correct
16 entries of all transactions relating to the Pledged Revenues.

17 (F) AUDITS. The City shall, within 270 days following the close of each
18 Fiscal Year, cause an audit of its books and accounts relating to the Pledged Revenues
19 to be completed by an Independent Accountant showing the receipts and disbursements
20 in connection with the Pledged Revenues.

21 (G) DUTY TO IMPOSE TAX. If State law or the City Charter or any City
22 ordinance or part thereof, which affects the Pledged Revenues, shall ever be held to be
23 invalid or unenforceable, the City shall immediately take any action which is legally
24 available to the City necessary to produce sufficient Pledged Revenues to comply with
25 the obligations of the City under the Bond Ordinance.

26 (H) IMPAIRMENT OF CONTRACT. In accordance with Section 3-31-
27 6(C) NMSA 1978, no law, ordinance or resolution of the City which affects the Pledged
28 Revenues or the Series 2024 Bonds shall be repealed or otherwise directly or indirectly
29 modified in such a manner as to impair Outstanding Series 2024 Bonds or obligations of
30 the City under the Bond Ordinance or any Related Documents, unless the Series 2024

1 Bonds or obligations have been discharged in full or provision has been fully made
2 therefor.

3 SECTION 25. REPRESENTATIONS AND WARRANTIES OF THE CITY. The
4 City represents and warrants that:

5 (A) HOME RULE POWER; EXISTENCE. The City has Home Rule
6 Powers and has been validly created and is operating under the laws of the State and the
7 City's Charter.

8 (B) AUTHORITY. The City has all requisite power and authority under
9 the laws of the State and the Home Rule Powers to enter into, execute and deliver the
10 Related Documents, to issue and sell the Series 2024 Bonds and to perform its covenants
11 contained in the Bond Ordinance.

12 (C) EXECUTION AUTHORIZED. The execution and delivery of the
13 Related Documents and use of the disclosure documents for the Series 2024 Bonds and
14 the issuance and sale of the Series 2024 Bonds have been duly authorized by the Council
15 and no further authorization or approval of such execution, use, delivery, issuance or sale
16 is required by law.

17 (D) ENFORCEABILITY OF BONDS. The Series 2024 Bonds, when
18 issued, delivered and paid for, shall constitute valid and binding special, limited
19 obligations of the City enforceable in accordance with their terms and entitled to the
20 benefits and security of the Bond Ordinance, subject to the limitations contained in the
21 Bond Ordinance and subject to any applicable bankruptcy, reorganization, insolvency,
22 moratorium or other laws affecting the enforcement of creditors' rights generally and the
23 enforceability of indemnification provisions and except to the extent that the enforceability
24 thereof may be limited by the availability of equitable remedies.

25 (E) ENFORCEABILITY OF RELATED DOCUMENTS. The Related
26 Documents, when executed and delivered by the City shall constitute valid and binding
27 special limited obligations of the City enforceable in accordance with their terms, subject
28 to any applicable bankruptcy, insolvency, moratorium or other laws affecting the
29 enforcement of creditors' rights generally and the enforceability of indemnification
30 provisions except to the extent that the enforceability thereof may be limited by the
31 availability of equitable remedies.

1 (F) NO CONFLICT. The execution and delivery of the Related
2 Documents, the Series 2024 Bonds and the other agreements contemplated by the Bond
3 Ordinance and compliance with the provisions thereof, shall not conflict with nor constitute
4 on the part of the City a breach of or a default under any existing law, court or
5 administrative regulation, decree, order or, to the knowledge of the City, any agreement,
6 indenture, mortgage or lease to which the City is a party or by which it is or may be bound.

7 (G) OTHER LIENS. Other than as described and identified by the Bond
8 Ordinance, there are no liens or encumbrances of any nature on or against the Pledged
9 Revenues on the date of adoption of the Bond Ordinance.

10 SECTION 26. TAX COMPLIANCE. The City covenants that it shall use, and shall
11 restrict the use and investment of, the proceeds of the Series 2024 Bonds issued on a
12 tax-exempt basis in such manner and to such extent as may be necessary so that (a) the
13 Series 2024 Bonds shall not (i) constitute private activity bonds, arbitrage bonds or hedge
14 bonds under Sections 141, 148 or 149 of the Code, or (ii) be treated other than as bonds
15 to which Section 103(a) of the Code applies, and (b) the interest thereon shall not be
16 treated as a preference item under Section 57 of the Code. The City further covenants
17 (a) that it shall take or cause to be taken such actions that may be required of it for the
18 interest on the Series 2024 Bonds to be and to remain excluded from gross income for
19 federal income tax purposes, (b) that it shall not take or authorize to be taken any actions
20 that would adversely affect that exclusion, and (c) that it, or persons acting for it, shall,
21 among other acts of compliance, (i) apply the proceeds of the Series 2024 Bonds to the
22 governmental purposes of the borrowings, (ii) restrict the yield on investment property as
23 required by the Code, (iii) make timely and adequate rebate payments or payments of
24 alternative amounts in lieu of rebate to the federal government, (iv) maintain books and
25 records and make calculations and reports, and (v) refrain from certain uses of those
26 proceeds and, as applicable, of property financed with such proceeds, all in such manner
27 and to the extent necessary to assure such exclusion of that interest under the Code.

28 Authorized Officers are authorized (a) to make or effect any election, selection,
29 designation, choice, consent, approval, or waiver on behalf of the City with respect to the
30 Series 2024 Bonds as the City is permitted or required to make or give under the federal
31 income tax laws, including, without limitation thereto, any of the elections available under

1 Section 148 of the Code for the purpose of assuring, enhancing or protecting favorable
2 tax treatment or status of the Series 2024 Bonds or interest thereon or assisting in the

4 compliance, reducing the rebate amount or payments of penalties, or making payments
5 of special amounts in lieu of making computations to determine, or paying, excess
6 earnings as rebate, or obviating those amounts or payments, as determined by that
7 officer, which action shall be in writing and signed by the officer, (b) to take any and all
8 other actions, make or obtain calculations, make payments, and make or give reports,
9 covenants and certifications of and on behalf of the City, as may be appropriate to assure
10 the exclusion of interest from gross income and the intended tax status of the Series 2024
11 Bonds, and (c) to give one or more appropriate certificates of the City, for inclusion in the
12 transcripts of the proceedings for the Series 2024 Bonds, setting forth the reasonable
13 expectations of the City regarding the amount and use of all the proceeds of the Series
14 2024 Bonds, the facts, circumstances and estimates on which they are based, and other
15 facts and circumstances relevant to the tax treatment of the interest on and the tax status
16 of the Series 2024 Bonds.

17 SECTION 27. EVENTS OF DEFAULT. Each of the following events is an "Event
18 of Default":

19 (A) NONPAYMENT OF PRINCIPAL. Failure to pay the principal of any
20 Series 2024 Bonds when the same becomes due and payable, either at maturity, or by
21 proceedings for prior redemption, or otherwise.

22 (B) NONPAYMENT OF INTEREST. Failure to pay any installment of
23 interest on any Series 2024 Bonds on the due date thereof.

24 (C) INCAPABLE TO PERFORM. The City shall for any reason be
25 rendered incapable of performing its obligations under the Bond Ordinance.

26 (D) DEFAULT OF ANY OTHER PROVISION. Default by the City in the
27 due and punctual performance of its covenants or conditions, agreements and provisions
28 contained in the Series 2024 Bonds or in the Bond Ordinance on its part to be performed,
29 and the continuance of such default (other than a default set forth in Sections 27.(A),
30 27.(B) or 27.(C)) for 60 days after written notice specifying such default and requiring the
31 same to be remedied has been given to the City by the Owners of 25% in aggregate

1 principal amount of the Series 2024 Bonds then Outstanding or the Series 2024 Bonds
2 Outstanding.

3 SECTION 28. REMEDIES UPON DEFAULT. Upon the happening and during the
4 continuance of any Event of Default, the Owners of not less than 25% in aggregate
5 principal amount of the Series 2024 Bonds then Outstanding affected by the Event of
6 Default, including but not limited to a trustee or trustees therefor, may proceed against
7 the City to:

8 (A) protect and enforce the rights of the Owners by mandamus or other
9 suit, action or special proceedings in equity or at law, in any court of competent
10 jurisdiction, either for the appointment of a receiver or for the specific performance of any
11 covenant or agreement contained in the Bond Ordinance or for the enforcement of any
12 proper legal or equitable remedy as those Owners may deem necessary or desirable to
13 protect and enforce their respective rights;

14 (B) enjoin any act or thing which may be unlawful or in violation of any
15 right of any Owner;

16 (C) require the Council to act as if it were the trustee of an express trust;
17 and

18 (D) any combination of those remedies.

19 All proceedings shall be instituted and maintained for the equal benefit of all
20 Owners of the Series 2024 Bonds then Outstanding. The failure of an Owner to exercise
21 any right granted by this Section 22 shall not relieve the City of any obligation to perform
22 any duty. Each right or privilege of any such Owner (or trustee or receiver therefor) is in
23 addition and cumulative to any other right or privilege and the exercise of any right or
24 privilege by or on behalf of any Owner shall not be deemed a waiver of any other right or
25 privilege of such Owner.

26 No remedy in the Bond Ordinance is intended to be exclusive of any other remedy
27 or remedies, and each and every such remedy shall be cumulative, and shall be in
28 addition to every other remedy given under the Bond Ordinance or now or hereafter
29 existing at law or in equity or by statute.

30 All rights, remedies and powers provided by the Bond Ordinance may be exercised
31 only to the extent that the exercise thereof does not violate any applicable provision of

1 law and all the provisions relating to an Event of Default or the exercise of remedies upon
2 the occurrence of an Event of Default are intended to be subject to all applicable

4 that they shall not render the Bond Ordinance invalid or unenforceable under the
5 provisions of any applicable law.

6 SECTION 29. APPLICATION OF MONEY. All money received with respect to
7 any right given or action taken under the provisions of the Bond Ordinance after the
8 occurrence, and during the continuance, of an Event of Default with respect to the Series
9 2024 Bonds, except as otherwise specified in the Bond Ordinance, after payment of the
10 costs, fees and expenses of the proceedings resulting in the collection of such money,
11 shall be deposited in the appropriate Debt Service Fund and applied to the payment of
12 the Series 2024 Bonds in accordance with the terms and provisions of Section 18 of this
13 Bond Ordinance.

14 Whenever money is to be applied pursuant to the provisions of this Section 29, it
15 shall be applied at such times, and from time to time, as the Paying Agent determines,
16 having due regard to the amount of money available for application and the likelihood of
17 additional money becoming available in the future. Whenever the Paying Agent
18 determines to apply such money, the Paying Agent shall fix a Special Record Date and
19 the date (which shall be an Interest Payment Date unless the Paying Agent deems
20 another date more suitable) upon which payment is to be made and on such date interest
21 on the amounts of principal to be paid on such dates shall cease to accrue. The Paying
22 Agent shall give notice to the Owners of the deposit of any such money and of the fixing
23 of any such date, and shall not be required to make payment of principal to the Owner of
24 any Series 2024 Bonds until presented to the Paying Agent for appropriate endorsement
25 or for cancellation if fully paid.

26 SECTION 30. DUTIES UPON DEFAULT; RIGHTS CONFERRED. Upon the
27 happening and during the continuance of any Event of Default, the City will do and
28 perform all proper acts on behalf and for the Owners to protect and preserve the security
29 created for the payment of the Series 2024 Bonds and any Payment Obligations and to
30 insure the payment of the Debt Service Requirements promptly as the same become due.
31 The Owners of not less than 25% in aggregate principal amount of Outstanding Series

3 SECTION 31. DEFEASANCE.

4 (A) DEFEASANCE OF BOND ORDINANCE. If, when all Series 2024
5 Bonds become due and payable in accordance with their terms or otherwise as provided
6 in the Bond Ordinance and the entire amount of the principal of, premium, if any, and
7 interest due and payable on all of the Series 2024 Bonds is paid or if provisions are made
8 for the payment thereof when due and payable, and all other sums payable under the
9 Bond Ordinance are paid, then all covenants, agreements and other obligations of the
10 City to the Owners of the Series 2024 Bonds shall cease, terminate and become void and
11 be discharged and satisfied. However, the covenants of the Bond Ordinance relating to
12 the rebate requirements of Section 148(f) of the Code shall survive until all applicable
13 requirements have been satisfied.

14 (B) SERIES 2024 BONDS.

15 (1) When all principal, interest and prior redemption premium, if
16 any, in connection with any Series 2024 Bond have been duly paid or provided for, the
17 pledge and lien of the Bond Ordinance, and all obligations hereunder (except as provided
18 for in Section 32), shall be discharged with respect to that Series 2024 Bond and that
19 Series 2024 Bond shall no longer be deemed to be Outstanding within the meaning of
20 the Bond Ordinance. There shall be deemed to be such due payment or to be adequate
21 provisions for the prompt and complete payment of a Series 2024 Bond when the City
22 has placed in escrow and in trust with a commercial bank or trust company located within
23 or without the State and exercising trust powers, an amount sufficient (including the
24 known minimum yield from Defeasance Obligations in which such amount may be initially
25 invested) to meet all requirements of principal, interest and prior redemption premium, if
26 any, on that Series 2024 Bond as the same become due to its final maturity or upon the
27 designated prior redemption date. The Defeasance Obligations shall become due prior to
28 the respective times at which the proceeds thereof shall be needed, in accordance with
29 a schedule established and agreed upon between the City and such bank or trust
30 company at the time of the creation of the escrow, or the Defeasance Obligations shall

1 be subject to redemption at the option of the owners thereof to assure such availability as
2 so needed to meet such schedule.

3 (2) If any Series 2024 Bonds are deemed to be paid and
4 discharged pursuant to this Section 31, within 15 days after the date of defeasance, the
5 City shall irrevocably direct the Fiscal Agent to give written notice to each Owner of Series
6 2024 Bonds deemed paid and discharged at the address shown on the Bond Register on
7 the date on which those Series 2024 Bonds are deemed paid and discharged. The notice
8 shall state, to the extent applicable, the same information required by Section 6.(D) for
9 the redemption of Series 2024 Bonds and shall describe the Defeasance Obligations.

10 SECTION 32. SURVIVAL OF CERTAIN PROVISIONS. Notwithstanding the
11 foregoing, with respect to Series 2024 Bonds deemed paid pursuant to Section 31.(B),
12 any provisions of the Bond Ordinance which relate to indemnification and the payment of
13 fees and expenses, the payment of the principal of and premium on Series 2024 Bonds
14 at maturity or on a prior redemption date, interest payments and dates thereof, exchange,
15 registration of transfer and registration of Series 2024 Bonds, replacement of mutilated,
16 destroyed, lost or stolen Series 2024 Bonds, the safekeeping and cancellation of Series
17 2024 Bonds, non-presentment of Series 2024 Bonds, the holding of money in trust and
18 payments to the Fiscal Agent in connection with all of the foregoing, shall remain in effect
19 and be binding upon the Owners of Series 2024 Bonds and the Fiscal Agent for those
20 Series 2024 Bonds, notwithstanding the release and discharge of the Bond Ordinance.
21 The provisions of this Section 32 shall survive the release, discharge and satisfaction of
22 the Bond Ordinance.

23 SECTION 33. NOTICES. Except as otherwise specifically required in the Bond
24 Ordinance, notice with respect to the Series 2024 Bonds shall be effective when received
25 and it shall be sufficient service of any notice, request, demand or other paper if the same
26 is given: (i) orally, or (ii) by certified or registered mail, or (iii) by Electronic Means, or (iv)
27 hand delivered; provided that any notice given orally, including notice by telephone, must
28 be confirmed by notice in writing as set forth in clause (ii), (iii) (except by telephone) or
29 (iv) above initiated within one Business Day after oral notice is given. Notice shall be
30 given as follows:

25 to each Owner of Series 2024 Bonds affected by such event, at his address as it appears
26 on the register for the Series 2024 Bonds. In any case where notice to an Owner of
27 Series 2024 Bonds is given by mail, neither the failure to mail such notice nor any defect
28 in any notice mailed to any particular Owner of Series 2024 Bonds shall affect the
29 sufficiency of such notice with respect to any other Owner, and any notice which is mailed
30 in the manner provided in this paragraph shall conclusively be presumed to have been
31 duly given.

10 New York 10007, (b) to S&P at: Standard & Poor's Corporation, Attention: Municipal
11 Finance Department, 55 Water Street, New York, New York 10041, and (c) to Fitch at:
12 Fitch Ratings, One State Street Plaza, New York, New York 10004.

13 SECTION 34. AMENDMENT OF BOND ORDINANCE.

14 (A) LIMITATIONS UPON AMENDMENTS. Prior to any Series 2024
15 Bonds being issued, the Bond Ordinance may be amended by ordinance or resolution of
16 the Council without the consent of Owners. After Series 2024 Bonds have been issued,
17 the Bond Ordinance may be amended by ordinance or resolution of the Council without
18 the consent of Owners:

- 19 (1) To cure any ambiguity, or to cure, correct or supplement any
20 defect or inconsistent provision contained in the Bond Ordinance;
- 21 (2) To grant to the Owners any additional rights, remedies,
22 powers or authority that may lawfully be granted to them;
- 23 (3) To obtain or maintain a rating or shadow rating on any Series
24 2024 Bonds from any rating agency which amendment, in the judgment of Bond Counsel,
25 does not materially adversely affect the Owners;
- 26 (4) To achieve compliance with federal securities or tax laws; and
- 27 (5) To make any other changes in the Bond Ordinance which, in
28 the opinion of Bond Counsel, is not materially adverse to the Owners.

29 (B) ADDITIONAL AMENDMENTS. Except as provided above, the Bond
30 Ordinance may only be amended or supplemented by ordinance adopted by the Council
31 without receipt by the City of any additional consideration, but with the written consent of

1 the Owners of a majority of the principal amount of the Outstanding Series 2024 Bonds
2 which are affected by the amendment or supplement (not including Series 2024 Bonds

- 5 (1) An extension of the maturity of any Series 2024 Bonds; or
- 6 (2) A reduction in the principal amount of, premium, if any, or
7 interest rate on any Series 2024 Bonds; or
- 8 (3) The creation or continuance of a lien on or a pledge of the
9 Pledged Revenues ranking prior to the lien or pledge of Obligations on the respective
10 Pledged Revenues; or
- 11 (4) A reduction of the principal amount of Series 2024 Bonds
12 required for consent to such amendment or supplement.

13 (C) NOTICE OF AMENDMENT. Notice of a proposed amendment
14 requiring the consent of the Owners shall be mailed to the Owners of the Series 2024
15 Bonds then Outstanding affected by the amendment at their addresses as the same last
16 appear in the registration books kept by the Registrar. Such notice shall briefly set forth
17 the nature of the proposed amendment and shall state that copies of the instrument
18 pertaining to such amendment are on file at the principal corporate office of the Registrar
19 for inspection by all Owners. If, within 60 days or such longer period as shall be prescribed
20 by the City following the giving of such notice, the requisite percentage of Owners affected
21 by the amendment have consented to and approved the amendment, the amendment
22 shall become effective and no Owner shall have any right to object to such amendment,
23 or the operation thereof.

24 SECTION 35. MANNER OF EVIDENCING OWNERSHIP OF SERIES 2024
25 BONDS. Any request, direction, consent or other instrument provided or required by the
26 Bond Ordinance to be signed and executed by the Owners may be in any number of
27 concurrent writings of similar tenor and may be signed or executed by Owners in person
28 or by an agent appointed in writing. Proof of the execution of any such request, direction
29 or other instrument or of the writing appointing any such agent and of the ownership of
30 the applicable Series 2024 Bonds, if made in the following manner, shall be sufficient for
31 any of the purposes of the Bond Ordinance and shall be conclusive in favor of the Fiscal

1 Agent and the City with regard to any action taken by them, or either of them, under such
2 request or other instrument, namely:

3 (A) The fact and date of the execution by any person of any such writing

5 take acknowledgments in such jurisdiction that the person signing such writing
6 acknowledged before him the execution thereof or by the affidavit of a witness of such
7 execution; and

8 (B) The ownership of Series 2024 Bonds shall be proved by the Bond
9 Register.

10 Any action taken or suffered by the Fiscal Agent pursuant to any provision
11 of the Bond Ordinance, upon the request or with the assent of any person who at the time
12 is the Owner of any Series 2024 Bonds, shall be conclusive and binding upon all future
13 Owners of the same Series 2024 Bonds.

14 SECTION 36. APPLICABLE LAW. The Bond Ordinance shall be governed by the
15 laws of the State without reference to choice of law principles thereof.

16 SECTION 37. PAYMENTS AND PERFORMANCE ON BUSINESS DAYS.
17 Except as otherwise required in the Bond Ordinance: (i) any covenant required to be
18 performed on any date which is not a Business Day may be performed on the first
19 Business Day thereafter and (ii) if the date for any payment on the Series 2024 Bonds at
20 a place of payment shall be other than a Business Day, then payment shall be made on
21 the next succeeding Business Day, and no interest shall accrue for the intervening period
22 other than as specifically provided for in the Bond Ordinance.

23 SECTION 38. LIMITATION OF RIGHTS. With the exception of rights in the Bond
24 Ordinance expressly conferred, nothing in the Bond Ordinance or in the Series 2024
25 Bonds, expressed or implied, is intended or shall be construed to give to any Person other
26 than the Owners, the Fiscal Agent, the City and the parties to which such right, remedy
27 or claim is expressly granted by the Bond Ordinance or the Series 2024 Bonds, any legal
28 or equitable right, remedy or claim under or in respect to the Bond Ordinance or the Series
29 2024 Bonds or any covenant, condition or stipulation of the Bond Ordinance or in the
30 Series 2024 Bonds, and all covenants, stipulations, promises and agreements in the Bond
31 Ordinance and in the Series 2024 Bonds shall be for the sole and exclusive benefit of the

1 Owners, each Insurer, the City and the parties to which such right, remedy or claim is
2 expressly granted.

3 SECTION 39. DELEGATED POWERS. The officers of the City are authorized
4 and directed to take all action necessary or appropriate to effectuate the provisions of the
5 Bond Ordinance, including, without limitation, the delivery of a "deemed final" certificate
6 relating to the Preliminary Official Statement, the publication of notice of adoption of the
7 Bond Ordinance, the distribution of material relating to the Series 2024 Bonds, the printing
8 of the Series 2024 Bonds, certificates pertaining to the Series 2024 Bonds and the
9 delivery of and security for the Series 2024 Bonds as may be reasonably required by the
10 Investment Bankers.

11 The Chief Financial Officer of the City, or his successor in interest, is hereby
12 authorized and directed to make such changes or corrections to the procedures
13 established in the Bond Ordinance relating to the times of day or the days on which
14 actions are required to be taken, or the persons responsible for particular actions, the
15 form of notice of the occurrence of events, the types and forms of actions required and
16 other similar administrative matters which, in his judgment, are necessary and appropriate
17 to accomplish the purposes of the Bond Ordinance. The Chief Financial Officer, or his
18 successor in interest or title, shall give notice of any such changes or corrections to all
19 persons affected thereby, to Bond Counsel for the City and shall file with the City Clerk a
20 certificate of such changes and corrections.

21 Pursuant to the Supplemental Public Securities Act, Section 6-14-8 et seq.,
22 NMSA 1978, the Chief Financial Officer, Director of the Department of Finance and
23 Administrative Services and the City Treasurer are each hereby delegated authority to
24 execute the Bond Purchase Agreement, the Sale Certificate and to determine any or all
25 of the final terms of the Series 2024 Bonds, subject to the parameters and conditions
26 contained in this Bond Ordinance. The Chief Financial Officer, Director of the Department
27 of Finance and Administrative Services or the City Treasurer shall present the Sale
28 Certificate to the Council in a timely manner, before or after delivery of the Series 2024
29 Bonds, at a regularly scheduled public meeting of the Council.

30 SECTION 40. IMMUNITY OF MAYOR, COUNCIL MEMBERS,
31 COMMISSIONERS, OFFICERS AND EMPLOYEES OF CITY. No recourse shall be had

1 for the enforcement of any obligation, promise or agreement of the City contained in the
2 Bond Ordinance or in any Series 2024 Bonds for any claim based thereon or otherwise

4 his individual capacity, past, present or future, of the City or of any successor to the City,
5 whether by virtue of any constitutional provision, statute or rule of law, or by the
6 enforcement of any assignment or penalty or otherwise. It is expressly agreed and
7 understood that no personal liability shall attach to, or be incurred by, any Mayor, Council
8 member, officer or employee, as such, past, present or future, of the City or of any
9 successor to the City, either directly or through the City or any successor to the City. All
10 personal liability against every such Mayor, Council member, officer and employee is, as
11 a condition of, and as part of the consideration for, the adoption of the Bond Ordinance,
12 expressly waived and released.

13 SECTION 41. LIMITATION OF ACTION. After the passage of 30 days from the
14 publication required by Section 46, any action attacking the validity of any proceedings
15 had or taken by the City preliminary to and in the authorization and issuance of the Series
16 2024 Bonds shall be perpetually barred.

17 SECTION 42. BOND ORDINANCE IRREPEALABLE. After any of the Series
18 2024 Bonds are issued, the Bond Ordinance shall be and remain irrevocable until all
19 Series 2024 Bonds and the interest thereon shall be fully paid canceled and discharged,
20 as provided in the Bond Ordinance, or there has been defeasance as provided in the
21 Bond Ordinance.

22 SECTION 43. SEVERABILITY CLAUSE. If any provision of the Bond Ordinance
23 shall be held or deemed to be or shall, in fact, be inoperative or unenforceable as applied
24 in any particular case in any jurisdiction because it conflicts with any other provision or
25 provisions of any constitution or statute or rule of public policy, or for any other reason,
26 such circumstances shall not have the effect of rendering the provision in question
27 inoperative or unenforceable in any other case or circumstance, or of rendering any other
28 provision or provisions in the Bond Ordinance invalid, inoperative, or unenforceable to
29 any extent whatever.

5 ordinances, or parts thereof, inconsistent with the Bond Ordinance are repealed to the
6 extent only of such inconsistency. This repealer shall not be construed to revive any
7 bylaw, order, resolution or ordinance, or part thereof, heretofore repealed.

8 SECTION 45. RECORDING; AUTHENTICATION; PUBLICATION; EFFECTIVE
9 DATE. Upon due adoption of this Bond Ordinance, it shall be recorded and preserved by
10 the City Clerk, authenticated by the signature of the President of the Council and City
11 Clerk, and approved by the Mayor and the seal of the City impressed hereon, and the title
12 and general summary of the subject matter contained in the Bond Ordinance
13 (substantially in the form set out in Section 46) shall be published in a newspaper which
14 maintains an office and is of general circulation in the City, in accordance with law. The
15 Bond Ordinance shall be effective, assuming approval of at least seven members of the
16 Council, five days after publication. If a majority of the Council, but less than seven
17 members, votes in favor of adopting the Bond Ordinance authorizing the issuance of
18 Series 2024 Bonds, the Bond Ordinance is adopted but shall not become effective until
19 the question of issuing the Series 2024 Bonds is submitted to a vote of the qualified
20 electors for their approval at a special or regular local election.

21 SECTION 46. SUMMARY FOR PUBLICATION. The form of this Bond Ordinance
22 for the purpose of publication shall be substantially as set forth in this Section, and the
23 Council hereby declares that the publication prescribed shall be conclusive of the
24 sufficiency of such form:



To fund several projects underway, including Cibola Loop Mutli-generational center, the Westside Emergency Housing Shelter, the Gibson Health Hub, shelter and support services and enhancing public safety through acquisition of state-of-the-art police helicopter.


