According to ¶270 of the Court Approved Settlement Agreement the SW CPC states the following as their Annual Report:

The southwest area of Albuquerque is unresponsive, and the Council struggles to engage with the community participants in a meaningful and relevant way. The Council continues to struggle to have a membership willing to devote the time necessary to engage community participants and review/study the areas needed to offer a meaningful recommendation.

As each person moved through the membership “ranks” to be a leader, they resigned instead. The current members (as of December 2022) are disheartened with engaging and being relevant to the Southwest Area Command community participants.

No recommendations were made to APD on behalf of the SW CPC during 2022.
