- 6. New Mexico State Representative Meredith Dixon**

 - Catalytic converters mentioned in last year's session and got addressed in the metal theft portion of the crime bill.
 - Organized crime bill

- Additional funding for law enforcement recruitment, last session put fifty million dollars for recruitment and retention.
- Additions fund to support recruitment and hiring of public defenders and district attorneys.
- Working with APD and state police on revision on the federal equitable sharing program
- Working a bad actor database: allow law enforcement agencies to identify and cross reference of people they are hiring if they had trouble in other jurisdiction.
- Gun safety bills or gun violence prevention bills
- A bill to change the age of purchasing an AR-15
- Discussions on the red flag law or emergency protection order
- Funding for affordable housing, and substance abuse treatments programs
