5. **Lt. Chris Patterson DWI/Swing Motor**
  - Swing shift motor unit: 1 Sgt and 4 officers city wide motor unit their shifts are from 4PM to 2AM.
  - Reduction in number of fatalities and serious injuries call out. Last year there were 26 fatalities and this year it is 21 fatalities, a decrease in serious injury call outs.
  - Department wide last year: 15,395 citations

- YTD: 24, 708 citations (double number of citations)
- DWI last year: 435
  - YTD: 537
- Racing last year: 9 citations
  - YTD: 26 citations
- Modified exhaust last year: 88 citations
  - YTD: 120 citations
- This year alone the traffic division out of 15, 395 citations issues 6,941 were from the division. The YTD is 14,533 citations.
- Department has 30 motor officers and 7 DWI officers.
  - Last year 265 DWI arrest
  - YTD: 544 DWI arrest plus 10 impaired drivers
  - Last year: 9 racing citations
  - This year 29 racing citations
- City council passed the spectators statue – Individuals who are watching these street racing will get a citation. Last count of 83 citations in spectators and illegal street racing.
  - Last year – 41 modified exhaust citations
  - YTD – 65 modified exhaust citations

#### **6. NW crime report Lt. Jeff Abernathy**

- Last 30 days ending May 18, 2022
  - Auto burglaries – 35
  - Residential burglaries – 10
  - Stolen vehicles – 38
  - Commercial burglaries – 18
  - Robberies – 7
  - Traffic stops thru May 18<sup>th</sup> – 358 citations, about 20 traffic stops day
  - YTD – traffic citation fluctuates as it stays between the 500 to 600 range.

  - Business coalition attend the De-escalation training on May 31, 2022
