4. NW Area Commander Chris Patterson's crime update

- The officers are almost completed with OJT, and at the end of the month six new officers will be added to the NW area command.
- The officers are using a new CAD system and learning the new system.
- Last year the crime stats were down.
- Violent crimes overall are down 67%
 - o Robbery down 16%
 - o Aggravated assaults down 4%
 - \circ Sex crimes down 5%
- Property crime
 - o Auto burglary is down 22%
 - o Burglary up 12%
 - Shoplifting up 82%, this is due to retailers reporting more.
 - The PRT team recovered over \$10,000 in merchandise

 \circ Traffic issues – The numbers are from the NW area command only

- The twenty-eight-day operation they had 422 citations including 111 traffic stops.
- The motor unit was on Coors and Sequoia in a two-hour time frame they issued 100 citations.
- They are going to be adding more speed cameras on Sequoia.

7. Aja Brooks Executive Assistant U.S Attorney

- The IMR 19 report came out
- The city reached 100% in primary compliance
 - o 100% in secondary compliance
 - \circ 96% in operational compliance
 - \circ There are paragraphs in compliance and some paragraphs are not which
 - can relate to the civilian police oversight agency and board.
- They submitted a motion for partial termination.
 - \circ The motion for the paragraph that has the CPC to be removed.
 - \circ Request to have 93 paragraphs moved to be terminated

• The paragraphs are 43% in self-assessment.

 \circ The paragraphs that remain in monitor are 57%
