- 3. Approval of October 2024 Minutes** – Approved
- 4. New Business** – election

- 5. Valley Residents Concern**
  - The residents were told to call the police even when they hear something.
  - The president of the West Old Town Neighborhood Association receives CAD reports and reports back to his neighborhood.
- 6. Valley Area Command crime update with Commander Sanchez.**
  - These statistics are from 2024
    - Sex crimes – down 22%
    - Property crime/robbery – down 9%
    - Burglary – up 23%
    - Shoplifting – up 5%
    - The commander's goal for 2025 is to focus on property crime.
    - The Valley watch commanders came up with the idea of focusing on different crimes throughout the city. Different shifts would concentrate on different problems, for example, the day shift would focus on traffic enforcement.
    - By the end of 2025 the goal is to bring these crimes down by 50%

- Auto theft is up 2% from 2023. The apartment complexes are where the auto thefts occur.

#### **7. APD Superintendent of Police Reform Eric Garcia**

- Joined by IAFD Cmdr Scott Norris
- Superintendent oversees both internal affairs force division and internal affairs professional standards.
- Disciplinary review process
  - Reduce disciplinary authorities from twenty to four.
  - There are two commanders in professional integrity
  - The final review goes to Eric Garcia
- The superintendent was under in charge of the Police Academy, which is currently, they are under the Chief of Police and only respond to the deputy chiefs.
- Overall CASA Compliance
  - May 2022 IMR 15 – 70%
  - Nov 2022 IMR 16 – 80%
  - May 2023 IMR 17 – 92%
  - Nov 2023 IMR 18 – 94%
  - May 2024 IMR 19 – 96%
  - Oct 2024 IMR 20 – 99%
- CASA: There are currently four paragraphs being monitored. All other paragraphs are in operation compliance.
  - May 2022 – 23% compliance
  - Nov 2022 – 57%
  - May 2023 – 87%
  - Nov 2023 – 97%
  - May and Oct 2024 – 100%
