

It's fairly well known that God gave a set of laws and with it guidelines for the enforcement of those laws and penalties for those who broke the law. Any law is essentially meaningless without enforcement. The people in Bible times may not have had a police force as we think of one today, but they definitely had those who promoted justice by enforcing the law. The Bible references watchmen, armed guards, and judges and examples of law enforcement.

God is a God of justice, and He demands justice of His people, and this implies the necessity of law enforcement giving the responsibility of enforcing the law and thereby maintaining justice to man. "Defend the weak and the fatherless; uphold the cause of the poor and the oppressed. Rescue the weak and the needy; deliver them from the hand of the wicked" Psalm 82:3-4.

Romans 13 deals with submission to government authorities, and the same passage is instructive on the purpose of law enforcement and police work: "Rulers hold no terror for those who do right, but for those who do wrong. The one in authority is God's servant for your good. But if you do wrong, be afraid, for rulers do not bear the sword for no reason. They are God's servants, agents of wrath to bring punishment on the wrongdoer" Romans 13:3-4. Police officers or peace officers represent the "rulers" mentioned in this passage and extend their authority.

Therefore, a person involved in law enforcement or police work is doing a good and godly thing. The police officer who enforces the just law of the land should consider himself or herself God's servant and, toward the lawbreaker, an agent of God's wrath sent to keep the peace. One of the most important jobs of every police officer is the restraint of evil in society, a dangerous career, a noble calling, and a profession consistent with a biblical desire for justice and righteousness.

Not everyone likes police officers, but without a doubt everyone must agree that the role of police in our lives has only intensified over the last decade. Violent protests, evil doers, and all sorts of crimes though often driven by poverty and hopeless situations of people who commit them, cannot and shouldn't be tolerated.

Why would anyone want to be a police officer? I thought about it myself at one time, but that door didn't open for me. Perhaps some think it is their duty to do something for the local community. Without a doubt, one can contribute to society in other various ways. There are a multitude of other jobs or just volunteering, being a good citizen, adhering to the rules, respecting the laws or applying their education or talents to other vocations. Or perhaps they just feel the right role for them in society is that of a police officer; being out there on the streets, helping to prevent crime, or minimize the damage, making sure that the offenders get punished, and simply making sure that people aren't afraid to walk on the streets. Or some may just feel inspired by a family member and follow the same dream. Some may consider police work as an entry level first step where the final goal is much greater as they journey through life. Others may see a career in law enforcement as steady employment with good benefits, a person who sees him or herself physically and mentally strong, a team player, and overall considers themselves a good candidate for the job and who understands the risks.

Whatever the reasons Ms. McDermott thank God we have men and women that are still willing to serve as police officers, they are God's servant for our good. They are doing a good and godly thing. We must never forget that one of the most important jobs of every police officer is the restraint of evil in society, it's a dangerous career, but also a noble calling, and a profession consistent with a biblical desire for justice and righteousness.

Ms. McDermott we know this applies to foot patrols, bicycle patrols, motorcycle patrols, car patrols, SUV, truck or horse mounted patrols and the officer behind the desk, all of them. I know that the demands on all police officers have increased, and I commend and thank them all for their service.

I write this letter as a letter of commendation specifically written regarding the Albuquerque Police Department's Horse Mounted Unit. Ma'am, these officers are unique in that they can accomplish quickly with intimidation what no other officers can. Their response time is unmatched as I have witnessed them cut through traffic and crowds shouting and yelling to move crowds like no siren or emergency vehicle lights can. When an order is given by one of these officers to move one would be wise to move. I witnessed a man many years ago, a foolish man in my opinion, that would not move when ordered to by horse mounted law enforcement officers, he could have caused others to get hurt. Fortunately, he suffered only a bump and some embarrassment. Apparently, he thought he could stand up against an oncoming determined police sergeant mounted on a horse, well, he thought wrong. Fortunately, the disturbance was stopped despite certain individuals and the possible riot disrupted.

I don't have to tell you I am sure you already know this since the Albuquerque Police Department Horse Mounted Unit was started in 1977, that the added height and visibility that the horses give their riders allows officers to observe a wider area, and it also allows people in the wider area to see the officers, which helps deter crime and helps people find officers when they need them. When employed for crowd control, such as recently occurred in downtown Albuquerque, the mob was dispersed quickly as has been done several times this summer including the necessity for downtown Horse Mounted Unit night patrol.

The Horse Mounted Unit officers know and are ready and prepared to encounter troublemakers or offenders, the worst in society. These officers have worked overtime including the graveyard shift, they have missed out on family time and have cancelled family events. I have no doubt they have tired, but they are dedicated to their duties and will continue to do so throughout the summer as required. Why? Because that is what they do, they are sworn to protect and serve and after all they are Albuquerque's finest! I have personally thanked them, and I think you and their superiors should do the same, perhaps you already have. Thank you.

Over the years on several occasions, I have observed the Horse Mounted Unit patrolling downtown dispersing crowds, likewise at the NM State Fair, at the Balloon Fiesta, serving as dignitary protection, and they are superb at good old public relations. The public just loves them, and the officers are exceptionally friendly, they answer the same questions who knows how many times with a smile on their face, the children are intrigued by them asking "what's his name?" and the horses are trained for it all. The officers sit handsomely tall and proudly in the saddle and the horses are always well kempt and ready for duty.

It brought tears to my eyes, and I had a great sensation of pride as I watched the Albuquerque Police Department's Horse Mounted Unit escort slain NM State Police Officer Justin Hare's remains to the church for his memorial service in March of this year. What a great honor for them. We must not overlook these police officers and never consider them nonessential. What an asset this unit is to the Albuquerque Police Department and to the community of Albuquerque, New Mexico.

Some people such as I just simply love and respect police officers and appreciate what they do for the community. I am writing you this letter as a commendation letter for the Albuquerque Police Department Horse Mounted Unit, and I have the officer's names that I would like recognized. I am requesting that these officers receive a letter of commendation from the executive staff at the Albuquerque Police Department such as from their lieutenant, deputy commander, commander, deputy chief and chief or however it is that commendations are awarded by the Albuquerque

Police Department. I hope also that time and thought is given by the executive staff to praise and commend often all of the Albuquerque Police Department officers from the rookie to the ones that are about to retire.

I read the enclosed prayer out loud every night before I go to bed because **I Back the Blue** as I know you must do!

I walk my dog at the South Broadway park every morning. This summer, the park has frequently had many homeless people living there with suspected drug exchange and use. I haven't felt very safe, but I live in the neighborhood and have walked there for about 14 years. I've called 242 cops when it has been bad.

I'd like to complement APD for having a greater presence in/near the park recently. Earlier this week there were three APD officers that met at the park and had a brief meeting in the middle of the park. I witnessed the third officer pull up in the parking lot and all of them walk out of their vehicles to the middle of park. At the same time, there were quite a few homeless people I've seen at the park regularly walking away down the street. It seemed the police officers' presence caused a mass exodus! I've also seen a police service aid (PSA) vehicle driving by the park in the morning a few times this week. These might seem like small actions, but I think they make a difference.

What Outcome are you Seeking?

I'd like to continue to see police presence in/near the South Broadway Park. I realize emergencies take precedence and there are other parks in ABQ. However, brief meetings at random times should help keep people living there on their toes so they don't feel like they have free reign.
