## **Meeting Minutes**

- **I. Welcome and call to order** Chair Fine called to order the regular meeting of the Police Oversight Board at 5:02 p.m.
- **II. Pledge of Allegiance** Member St. John led the meeting in the Pledge of Allegiance.
- **III. Mission Statement** Chair Fine read the POB's Mission Statement.
- IV. Approval of the Agenda
  - **a)** A motion was made by Member Ring to approve the agenda. Vice-chair St. John seconded the motion. The motion was carried by the following vote:

- V. Public Comments Michael Zocholl. Mr. Zocholl is the Chair of the SW Citizen Policing Council and is in attendance to observe and learn about the POB and what they do.

  - a) Approval of the Minutes from October 12, 2017
    - 1. Copies of the draft minutes from October 12, 2017 POB meeting were distributed to each member in their packets.
    - **2.** A motion was made by Member Waites to approve the minutes as presented. Vice-chair St. John seconded the motion. There was no discussion. The motion was carried by the following vote:

#### VII. Discussion:

a) IMR-6. For more information as to the Independent Monitor's Report, please download this link: https://www.justice.gov/usao-nm/page/file/1007876/download

- 1. The Independent Monitor Report number 6 (IMR-6) was produced to the public on November 1, 2017 and filed in the Federal Court on the same date.
- **2.** IMR-6 will be presented to Judge Brack on November 16, 2017 at 9:00 a.m. at the Federal Court, 333 Lomas Blvd. NW, Albuquerque, NM, in the Chama Courtroom.
- **3.** Director Harness discussed the five points as it relates to IMR-6.
  - **a. CPOA Timelines for Investigation.** In order to address the timelines for CPOA investigations, the CPOA has planned a staff meeting to discuss this issue on Tuesday, November 14, 2017.
  - **b. CPOA Secondary Compliance.** The CPOA was taken out of secondary compliance by the Monitor based upon an administratively closed case in which the investigator did not review the lapel video. However, the monitor did agree with the closing of the case but they wanted the one step included in the investigation. This took us out of the 95% rate of secondary compliance.
  - c. APD's Struggle with Investigation and Reporting's on Use of Force. There was no discussion as to this topic.
  - d. Concept of De Minimis Use of force. Discussed the concept of De Minimis force, which has been introduced to the department but no training notice has taken place. De Minimis force is a definition APD is attempting to establish the use of force that would not be reportable or so small that the department would not have to report it.
  - e. APD's Specialized Units (e.g. SWAT, CIT)
    - i. The Monitor is pleased with the specialized units of APD as they are making great progress and are at or near full compliance under the Settlement Agreement.
    - **ii. APD SWAT Team.** Since IMR1, the Monitor has highlighted that APD SWAT has done a great job of incorporating the policy, trained to the policy, reviewing itself and then closing the loop to those trainings. In addition, they have been utilizing the matrix during an active call-out and follow the established protocols.
    - **iii. SWAT call-out numbers.** Discussed that there are an average of 10 activations a month. Director Harness will try to get the data for call-outs and the changes that have taken place.
    - iv. Job Well Done for APD SWAT.
      - Members discussed that they send a Job Well done to APD Commander McDonald and to the SWAT team for a job well done.

2. A motion was made by Member Ring to send a commendation to SWAT on its progress. Member St. John seconded the motion. There was no discussion after the motion. The motion was carried by the following vote:

- v. Accidental Discharge of Firearms. Discussed that the POB has not yet suggested that the accidental discharge of firearms be a part of a force review. Chair Fine suggested the Policy Subcommittee look at getting the suggestion submitted to the FRB.
- **4. Meeting Dates for IMR-6.** Discussed the dates that the parties of the CASA will be meeting with the Monitoring team as follows:
  - **a. Pre-Brack Meeting with Monitor.** Members Kass, Chair Fine, Vice-Chair St. John will attend the pre-Brack meeting at the US Attorney's office on November 14, 2017 at 1:00 p.m.
  - **b.** Judge Brack Settlement Conference. On November 16, 2017 at 9:00 a.m., POB Members (non-quorum) will attend the Judge Brack settlement conference hearing, which Dr. Ginger will present IMR-6 and members/parties will testify. The new Mayor-elect was invited to the hearing. No cell phones are allowed at the Federal court.
  - **c. Post-Brack Meeting.** On November 17, 2017 at 10:00 a.m., there will be a casual dress, Post-Brack meeting at the US Attorney's office to discuss the transition moving forward with a new mayor and a new APD Chief.

## b) Open Meeting Act Statement.

- 1. Annually, there is an OMA requirement resolution that the POB must approve. This item was tabled until Attorney Mark Baker can locate the statement. During item VIII, C, Attorney Mark Baker handed his IPad to the members for them to review the OMA statement, which is 2 pages long.

#### 1. Outreach Efforts.

- a. On October 9, 2017, Dr. Kass and the CPOA Outreach Coordinator Amanda Bustos attended the Silverhills Neighborhood Association to discuss the CPOA and the POB. There was a lot of interaction that took place.
- b. The Outreach Subcommittee members are continuing the outreach efforts and each try to attend a CPC meeting once a month and invite other POB members to attend a CPC meeting as well.
- 2. **CPOA Agency Brochure.** The agency brochure with the complaint/commendation form included is still in process as the graphic designer has not completed the brochure yet.
- 3. **Outreach Subcommittee Goals and Objectives.** The Community Outreach Subcommittee goals and objectives are being refined.
- 4. **New Community Outreach Subcommittee Member:** Member Valerie St. John will be joining the Community Outreach Subcommittee.
- 5. **Next Meeting:** The next meeting of the Community Outreach Subcommittee will be held on Thursday, December 7, 2017 at 5 p.m.

- 1. Policy on Policy Development. The Policy Subcommittee discussed the policy on policy development process in which it was recommended by Major Tyler that the POB Policy recommendation go directly to the Standard Operating Procedure Review Committee (SOPRC). Dr. Kass clarified for Chair Fine that the Policy Subcommittee will present policy to the POB before presenting to the SOPRC.
- **2. Tracking Policy System**. Discussed a work in progress policy tracking system. Dr. Miriam Verploegh from UNM is on contract and has done some work on how to track a policy that the POB is working on.
- **3. Ordinance Amendments.** Member Brown resurrected the amended ordinance, which is currently at City Council.
- **4. Public Input on Policies.** Dr. Kass attended a Policy Procedure Review Board (PPRB) meeting. After the meeting, Dr. Kass spoke with the meeting facilitator, who suggested that there would be some real change in terms of getting more public input as to policy creation.
- 5. CPC's Involvement in the Policy Process. Dr. Kass discussed that he attended a CPC meeting in which he presented the Code 3 policy and was able to get the input from the individuals at the CPC meeting. While the CPC's have their own process of introducing their policy recommendations, Dr. Kass feels that when POB members attend the CPC meetings, they can facilitate what policies the CPC's are interested in.

**1. CPOA Director Harness Evaluation.** Chair Fine discussed that Member Cruz has submitted the survey for the evaluation of Director Harness.

## XI. Reports from City Staff

- a) APD Major Jessica Tyler gave the following report for APD:
  - 1. Serious Use of Force Cases (CIRT) none available since May 2017. Major Tyler explained that the POB should start receiving cases the following week and if the POB does not start receiving cases, to reach out to her.
  - **2. 93-17 Policy Recommendation Update CYFD Referrals.** Discussed that the Chief Eden's letter responding the CPOA and POB disciplinary recommendations did not address the CYFD component from the findings letter sent to the citizen. Major Tyler will follow up on this.

## 3. No Response from Chief on I-22-2017.

- **a.** Mayor Tyler discussed that there was a delay but it is finalized and the letter will be sent to the POB early the following week.
- **b.** The timeframe of 30 days is difficult for the case to go through the Chain of Command. Chair Fine suggested that they notify the POB before the 30 days is up if they need an extension.
- **c.** The issue actually be contemplated with City Legal in the Amendment in the Ordinance as a way to deal with
- **d.** Julian Moya discussed that the amended ordinance has not been introduced to City Council yet for the reason that Councilor Winter wanted to get some feedback from APD and the APD union. Mr. Moya will be more than happy to work with Dr. Kass to work with other City Councilor's that could sponsor the amended ordinance.

## 4. Update on Citizen's Policy Academy

- **a.** Session Available by Video? Major Tyler checked their records and there are no current videos of any of the prior sessions.
- **b.** Major Tyler's staff at the Police Academy is working with Chair Fine to schedule dates for the Citizen Police Academy to be held in February 2018 for new POB members.
- **5. APD Statistical Data.** Major Tyler read the Statistical Data for the Month of October 2017. A copy of the following document titled: *Police Oversight Board, APD Internal Affairs, Statistical Data for the Month of September 2017* was distributed to the POB members. **See Attachment "A"**
- **6. SWAT Calls.** There were 68 call outs for year 2017. Prior to the CASA, they were averaging of 100-120 calls per year. The reason for the decrease in SWAT call outs is the matrix and the change in the policy in which SWAT does not go out on calls where the person is threatening suicide.

- 7. Accident Reports. Major Tyler will add this topic as an agenda item for the next small group meeting with TJ Wilham and members of the POB to discuss a better mechanism for reporting accident data to the POB.



Per the Ordinance, the POB composition is to consist of nine at-large members who:

"broadly represent the diversity and demographics of the City by way of, including but not limited to, cultural, gender and geographic diversity; and who are representative of the stakeholders of the police oversight process, and who reside within the City of Albuquerque." 9-4-1-5(A) ROA 1994.

Members serve three-year terms. Per the Police Oversight Ordinance, Board members must also meet the following requirements:

- He or she must not have been employed by law enforcement for one year prior to appointment; and
  - (2) He or she must successfully pass a background check; and
- (3) He or she must have a personal history lacking any pattern of unsubstantiated complaints against APD; and
- (4) He or she must have a demonstrated ability to engage in mature, impartial decision making; and
- (5) He or she must have a commitment to transparency and impartial decision making; and
  - (6) He or she must be a resident of the City of Albuquerque

Per Ordinance requirements for the Board's composition, listed above, Council Staff recommends Ms. Chantal M. Galloway be appointed to the Police Oversight Board.

BACKGROUND

In the summer of 2016, City Council Staff decided to open the application process for POB membership in order to refresh the City pool of pontential POB members and to outreach to certain underrepresentated areas of the City. The Ordinance requires that the Board broadly represent the demographics of the City by cultural, gender, and geographic diversity.

The Council Office published the Police Oversight Board Application webpage on it's website at 8:00am on June 1, 2016 and closed the the page and application process at 5:00pm on July 8, 2016. There were a total of 54 applications submitted. One applicant withdrew his application, two applicants lived outside of City limits, which disqualified them, and three applicants did not turn in their background waiver form, which disqualified them. This left 48 applications for the Selection Committee to review.



Dear Dr. Ginger, Me. Saucedo, Ms. Hernandez, and Mr. Mowrer:

I write this letter on behalf of the Police Oversight Board and the Civilian Police Oversight Agency. The purpose of this letter is to briefly outline topics we intend to present to Judge Brack on November 16, 2017.

We intend to present to Judge Brack our concerns regarding the following issues:

- APD's failure to present for the Board's review, in accordance with the CASA and City of Albuquerque Ordinance, Serious Use-of Force Cases, and Officer Involved Shootings.
- The Board's concerns regarding APD's Force Review Board. The FRB continues to
  operate outside APD Policy. Additionally, the departments fails to address the out of
  policy actions of FRB. Nor, has it proposed or written any policies to improve FRB's
  performance.
- APD's unilateral decision to prohibit CPOA's ability to download On Body Recording
  Device video in violation of APD Policy 2-8-5-G-4, which states, "Viewing and
  downloading OBRD recordings is for criminal investigations, administrative
  investigations, or authorized administrative purposes only."
- 4. APD's failure to deliver on it's commitments in this Court's Ordered Action Plan. Specific to the POB are the commitments to provide POB members with a Citizens Police Academy to accommodate a volunteer schedule.

We look forward to discussing this letter with the Monitor and the parties at our 1:00 meeting on November 14th.

Re: On Body Recording Device (OBRD) Video Downloads

Dear Dr. Ginger, Mr. Saucedo, Ms. Hernandez, and Mr. Mowrer:

On September 21, 2017 the Police Oversight Board sent a letter to Chief Eden regarding the Department's change in policy relating to the Civilian Police Oversight Agency's ability to download video evidence from evidence.com. The letter highlighted the CPOA's legitimate need to have the ability to download video, and the Department's obligation to do so.

On October 4, 2017 Chief Eden responded to the POB denying the Board's request citing a conversation he had with the Bernalillo County District Attorney's Office and other experts

with concerns about the integrity of released video in high profile police shootings. A rather ironic statement given this report from KRQE last night. <a href="http://krqe.com/2017/11/06/police-video-apd-takes-down-aggravated-assault-suspect/">http://krqe.com/2017/11/06/police-video-apd-takes-down-aggravated-assault-suspect/</a> The Chief could not cite one occasion where a downloaded video, in possession of the CPOA, was ever released or compromised the operations of APD.

On October 17, 2017 myself, and Chair Fine attended the weekly meeting between APD, the Monitor, and DOJ. The change in video protocol was on the agenda for discussion. This letter is a result of that discussion.

On October 24, 2017 I attended the weekly meeting between APD, the Monitor, and DOJ because the topic of video downloads was again on the agenda. During that meeting the parties were informed that under no circumstances would anyone be given a download of OBRD video. The new protocol for all interested parties to access video would be a link provided to evidence.com. The department further stated no one would be provided a copy of video even to meet a State of New Mexico Inspection of Public Records request. The department advised those in attendance no one has been provided downloaded copies of video in at least the last 60 days, in accordance with the new protocol. We now know that statement to be false. See:

- 1. October 25, 2017 KOB reporting on a Thanksgiving Arrest
- 2. October 26, 2017 KOB reporting on the Circle K Shooting Suspect
- 3. October 26, 2017 KOAT reporting on the Circle K Shooting Suspect

The media was provided a DVD download of those OBRD videos, in addition to the link I provided above.

This change in protocol has wide reaching implications beyond hindering the CPOA's ability to conduct fair and thorough investigations. It will affect the entire justice system. Moreover department has not provided a written Memo, Directive, Notice, or change in policy vetted through the department's policy development process.

The City Attorney requested we restrict our argument to the tenants of the CASA. However, it is our position this change not only breaches the CASA, but also the City of Albuquerque Oversight Ordinance, and APD's On Body Recording Devise Policy.

It is the agency's position that the change in policy is in violation of three paragraphs of the CASA: Paragraph 185, Paragraph 282, and Paragraph 283.

Paragraph 185 states: APD shall require personnel to cooperate with Internal Affairs Bureau and Civilian Police Oversight Agency investigations, including appearing for an interview when requested by an APD or Civilian Police Oversight Agency investigator and providing

all requested documents and evidence under the person's custody and control. Supervisors shall be notified when a person under their supervision is summoned as part of a misconduct complaint or internal investigation and shall facilitate the person's appearance, absent extraordinary circumstances.

The key to this paragraph of the CASA is the requirement to cooperate fully. This paragraph sets the standard and level of cooperation required of APD personnel when part of a CPOA investigation.

Paragraph 282 states: The City shall ensure that the agency, including its investigative staff and the Executive Director, have access to all APD documents, reports, and other materials that are reasonably necessary for the agency to perform thorough, independent investigations of civilian complaints and reviews of serious uses of force and officer-involved shootings. At a minimum, the City shall provide the agency, its investigative staff, and the Executive Director access to:

- all civilian complaints, including those submitted anonymously or by a third party;
- b) the identities of officers involved in incidents under review;
- the complete disciplinary history of the officers involved in incidents under review;
- d) if requested, documents, reports, and other materials for incidents related to those under review, such as incidents involving the same officer(s);
- e) all APD policies and training; and
- if requested, documents, reports, and other materials for incidents that may evince an overall trend in APD's use of force, internal accountability, policies, or training.

The key to this paragraph is the phrase; "independent investigations". It is impossible to complete an independent investigation if the CPOA must rely on APD to preserve evidence identified by the CPOA. Currently, the CPOA must request a viewing of a video related to a particular incident. Sometimes those requests are denied because the video does not have an incident number tagged to the video. The CPOA investigates incidents that may not have a number associated with it, therefore the video may be available for only a limited amount of time. It must also rely on APD to preserve this evidence to prevent the possible deletion of the video if it runs past the 120 day preservation requirement. That system has led to video being deleted before the completion of an investigation.

Prior to the change, CPOA would download a copy of the video and maintain it in the investigative file. This also facilitates the Monitor's request to review a full investigative file.

The CPOA is under Monitor review and has compliance obligations with the Monitor. Without a downloaded copy of the OBRD video used in an investigation, that file would be incomplete and take the agency out of compliance.

Paragraph 283 states: The City shall provide reasonable access to APD premises, files, documents, reports, and other materials for inspection by those appointed to the agency, its investigative staff, and the Executive Director upon reasonable notice. The City shall grant the agency the authority to subpoena such documents and witnesses as may be necessary to carry out the agency functions identified in this Agreement.

The City argues it is reasonable to provide access to video through evidence.com, but unreasonable to allow downloading of video. If we look beyond the CASA to the Oversight ordinance and APD's policy on OBRD we can determine what is reasonable.

The Ordinance 9-4-1-4 (C)(3)(b) states: APD shall provide POB members, the Director, and CPOA staff with reasonable access to APD premises, files, documents, reports, and other materials that are reasonably necessary for the agency to perform thorough, independent investigations, of civilian complaints and reviews of serious uses of force and office-involved shootings. However, any material protected from disclosure by law shall remain within the custody and control of APD at all times and will be handled in accordance with the applicable legal restrictions.

The only restriction cited in the ordinance is material protected from disclosure by law. These videos and the downloading of them are not protected by law. In fact, New Mexico's Inspection of Public Records Act requires an electronic copy be provided, if requested. Certainly, it is reasonable to expect an electronic copy of a video to complete a thorough investigation, without invoking the request under IPRA!

Lastly, the prohibition of downloading OBRD video violates APD policy. 2-8-5(G) (4) published 6-02-2017 states: *Viewing and downloading OBRD recording is for criminal investigations, administrative investigations, or authorized administrative purposes only.* 

In fact, a training video for APD personnel dated 7-31-2017 highlighted the changes in the policy including the above referenced paragraph.

It is not only reasonable for the CPOA to have the ability to download OBRD video it is supported by all the guidance from the CASA, the Oversight Ordinance, and APD policy.

Currently, not a single entity task with criminal or administrative investigations has any guidance as to how to proceed under these unilaterally imposed changes. As stated previously

these changes have far reaching implications beyond CPOA. It affects the entire justice system in Albuquerque.

We humbly request your support in our request to rescind this policy change and return to compliance with the CASA, the Oversight Ordinance, and current APD policy.
