

RESOLUTION OF THE DOMESTIC VIOLENCE AND SEXUAL ASSAULT COMMISSION NO. 2024-02 LETHALITY ASSESSMENT FOR FIRST RESPONDERS

NOW, THEREFORE, BE IT RESOLVED, that the DVSA Commission, in fulfillment of Its duties and powers as outlined in Section 2-6-18.4 of the Commission on Domestic Violence and Sexual Assault Ordinance, hereby recommends the implementation of a lethality assessment tool for first responders, including APD, BCSO and AFR, to be Utilized in domestic violence and sexual assault incidents:
