By APD:

- How long was the response time from the 911 call? **Average: 58 Minutes. If Priority 1 Call (generally indicates actively violent or weapon), average response time drops to 16 minutes.**
- How many DV calls resulted in arrests? **Out of 9,231 DV Calls to APD, 2,152 resulted in criminal charges being filed.**
 - Male: **1,583 YTD**
 - Female: **589 YTD**
 - Single
 - Dual or more
- How many sexual Assault calls? **445**
- How many SA calls a month resulted in Arrests? **11 criminal charges YTD**
- How many survivors were contacted? **Not available today**
- How many Felony DV cases for a detective follow up? **347 sent to Impact Detectives**
