Rules for Participants- Must participate in an eligible afterschool program. (Enrolled or drop-in)

- Must be 1-18 years of age to receive a meal.
- Must receive entire meal as a unit.
- Meal must be eaten on site.
- Do not abuse any food items. (throw or play with food)
- Clean up your area after you have finished your meal. (use trash dispensers)
- Any misconduct that disrupts the Food Service Program will not be tolerated.

All meals will be served on a first-come first-served basis. In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, religion, sex, gender identity (including gender expression), sexual orientation, disability, age, marital status, family/parental status, income derived from a public assistance program, political beliefs, or reprisal or retaliation for prior civil rights activity, in any program or activity conducted or funded by USDA (not all bases apply to all programs). Remedies and complaint filing deadlines vary by program or incident.
