## **Hospital Systems Reports**

**Lovelace-** nothing to report.

-Skilled nursing flyer in facilities is approved and will be distributed. The goal is to help clarify non-emergent transport options and reduce 911 usage for low acuity IFTs.

-Albuquerque Ambulance introduced new oxymask.

-3 cases of overdose on Xylazine. Treat as multiple drug overdose.

a. **Droperidol Update:** Down to 10 bottles of Ketamine. Hold the current vials as long as possible. Hope to have them restocked by August.

b. **ECMO Update:** Currently on hold AFR had a change of crews at station 3. The new crews need to be trained on mobile ECMO.

B. **Alternative dispatch discussion:** With high volumes in hospitals and EMS calls, AFR is exploring alternative dispatch telehealth options for low acuity calls, including an app called Good Sam. Waiting on Funding, maybe by the Fall.
