- Trauma Triage Update (Retrac)
 - o Update: triage tags received, to be distributed.
 - Looking to put together a test event.
 - September 16th Retrac meeting.

- Black Divert Language

- Black divert indicates a catastrophic failure of a hospital system (emergency, power outage, etc.).
- *Specialty divert: a specific specialty is down (Cath Lab, CT scanner down, etc).
- *Cyber-attack: a hospital is down to due to hack, MCB can meet to redirect if more than 24 hrs.
- A collective hospital system can only have 1 hospital on redirect at a time.
- EMS Saturation redirect: In individual diversions that aren't specialty or black divert, it is up to the EMS crew to
 determine if the divert in best for the patient. Stability of the patient/acuity of the patient is strongest consideration.
- o ReadyOp is not yet operational.
- Chief Ortiz will look into the operation of EM Resource notifications.

- Acid Remap/Pedi Stat Integration

- End of July they have their first client looking to extract data, that theyre BETA testing with.
- O TBA on full rollout.
- Ouick Cric
 - BCFD working on training.
- Suboxone SS

- o Special skill for suboxone admin for EMS personnel.
- o Options for initial use: Care Campus, with beds for clients. ACS working on patient consent and legal details.
- o AFR working on the training to roll out this special skills, tentatively for end of the 2024 year.
- ACS will be in charge of paperwork on scenes.

- Peds Transport

o Chief Ortiz will work on language for updates.

- Gateway

- o New gateway open. People that need shelter, low barrier, no medical needs. Excepting clients 8pm till the morning.

DOT Transition

- o Representatives from the DOT sharing rules changes.

 - Can't have drivers under the age of 21 y/o.
 - Background checks and drug test results at the readily available.
 - Redundancy on requiring an annual service report to DOT.
