I. Call to Order

VI. Comments on access and inclusion at the Albuquerque Museum

a. Bibi Baloyra, assistant director at the Albuquerque Museum, discussed her professional background and her awareness of the importance of actively promoting and building for access and inclusion in public spaces, such as museums. She described her intention to work with architects and curators to build the museum in a highly inclusive and accessible space for patrons with disabilities. She offered to host the ADAAC's May 2024 meeting at the Albuquerque Museum, and offered to provide a guided tour of an exhibit to the ADAAC and interested members of the public to get feedback on accessibility.

VII. Discussion of Inspection of Public Records Act request for information on accessible parking placards.

- a. Councilperson Ahrend discussed their efforts to get information on the number of accessible parking placards issued to residents of Albuquerque. The government responded to their initial IPRA request stating no information was available. They made a second request for information on the number of placards issued state-wide.
- b. The attendees then had a prolonged discussion about the shortage of accessible parking in the city; the need to educate the public about how people with invisible disabilities may have legitimate reasons to use accessible parking; and the possibility of implementing an app or some other solution to report cars illegally parked in designated accessible parking.
