- Metropolitan Redevelopment Agency Plans for the Area Terry Brunner, Director
- Very involved in the area, was here a year ago, buy sell & redevelop properties (currently we are in the near heights), they go after commercial & main thoroughfares, they are allowed to apply their special powers, they are not subject to the anti-donation clause, tax abatement for developers, they are usually in the bond funds 4.2 million every two years, tax increment financing is new & passed law that allow us to declare an MRA a tax increment financing, can leverage the taxes and the estimate is 150 million over the next 20 years. What they are doing around here: Sol housing 65 units, trying to purchase other properties in the vicinity, interested in the Adam property, Griffs lot, attempted to purchase CVS & Walgreens (they are not willing to sell). Kathryn & San Mateo ACS facility & market place-- will put out a request for interest for developers to see what the possibilities are and what can actually happen, then a formal RFP will be released. \$400,000 was put in the marketplace, choice neighborhood come in with a proposal and then enhance the entire up to 3million for plan and then 100 million to match (federal), San Mateo to Wyoming, Lomas to Gibson. Choice neighborhood and to get the strongest plan forward. Neighbors are asked to star their name on the list if they would like to be a part of the planning group. They are trying to market regionally for the RFPs, overall they are not getting a lot of developers. Lack of units overall are a big issue. Lots & buildings that can be built & renovated. Franklin plaza is being appraised East Central & Juan Tabo.

- Sandra asked when the community will be able to provide input, Terry said that he would inform them for the next meeting, is Walgreens/CVS responsible for the issues that are happening there? Terry said they would work with code enforcement to hold them accountable; Pete has been sending letters about having them fence off (CVS & Walgreens), crime is driving out business is NOT true.
- Grocery stores are a difficult business, he would like to look at the Kathryn for a grocery store and would like to find the perfect spot, they are willing to do studies expansion is also a good way and he suggests being really strategic opportunities, fair and square is off the table and if anyone knows about a vacant lot,
