1 2 MEMORANDUM OF UNDERSTANDING BETWEEN AFSCME LOCAL 624 BLUE 3 AND THE CITY OF ALBUQUERQUE 4 5 REGARDING MECHANIC POSITIONS HOLDING A CDL 6 THIS MEMORANDUM OF UNDERSTANDING ("MOU") is entered into by and between 7 the City of Albuquerque ("City") and the AFSCME Local 624 Blue Collar ("Union"), 8 9 (collectively, the "Parties") and serves as an addendum to the Agreement Between the City of Albuquerque and AFSCME Local 624 Blue Collar Union ("CBA") effective July 1, 2023, 10 which terminates on June 30, 2026. 11 12 WHEREAS, Section 40.5.1 of the CBA allows the Parties to enter into written 13 Memoranda of Understanding (MOUs) during the term of the CBA, and 14 15 16 WHEREAS, the Parties agree that the following positions: Vehicle Servicer 17 (B19), Mechanic Helper (B22), Tire Repairer (B25), Paint & Body (B31), Mechanic II (B32), 18 Mechanic III (B33), Body Shop Lead (B33), Lead Mechanic (B35), Electronic Tech (B35) 19 have been hard to recruit positions for the City and an increased Shift Differential will 20 improve the recruitment and retention of these positions, and 21 22 In the AFSCME 624 Blue Collar CBA 23 24 2.1.2 Employees whose regular work assignments begin during the times 25 designated below are eligible to receive shift differential for regular hours 26 worked or hours on approved leave with pay: 27 28 2.1.2.1 Swing Shift (\$.45 per hour) start time between 11:59am and 6:59 pm 29 2.1.2.2 Gravevard Shift (\$.60 per hour) start time between 7:00pm 30 and 3.59am 31 32 33 NOW, THEREFORE BE IT RESOLVED 34 35 I. **Term of MOU.** This MOU is effective the date the last party signs the 36 agreement and shall remain in full force until the current CBA expires or until 37 a successor Agreement is reached, whichever occurs last. 38 39 II. Article 2.1.2.1 of the CBA shall be amended to read as follows: 40 41 42 Swing Shift (\$.45 per hour) start time between 11:59am and 6:59 pm. 43 For (Vehicle Servicer (B19), Mechanic Helper (B22), Tire Repairer (B25), Paint 44 & Body (B31), Mechanic II (B32), Mechanic III (B33), Body Shop Lead (B33), Lead 45 Mechanic (B35), Electronic Tech (B35) employees holding a CDL, Swing Shift (\$1.45) 46 per hour) start time between 11:59am and 6:59 pm. 47

1 2 **No Further Agreement.** This MOU incorporates all the agreements, covenants, III. and understanding between the parties hereto concerning the pilot program to be 3 enacted hereunder, and all such agreements, covenants, and understandings have 4 been merged into this MOU. This MOU expresses the entire MOU and 5 understanding between the parties with respect to said services.
