
With these funds, the City has continued to make improvements to public safety, address homelessness, foster economic development, and support childhood education and the overall quality of life in our community.



CITY'S 2024 TOP LEGISLATIVE PRIORITIES

Public Safety Capital Investments

Expand Real Time Crime Center and Police Technology



\$20 Million Capital Request
State ICIP Project ID: 36874
LCS ID: 1046

The Real Time Crime Center has proven to be an invaluable tool for the Albuquerque Police Department's crime-fighting efforts. As the center has expanded, APD needs to broaden and integrate these technologies throughout the full metro area. APD seeks to create a center that would enable partners to share their informational, technological and subject matter expertise towards the common goal of lowering crime across the State.

This funding would create a true Fusion Center for the metro area, with interoperable software for all agencies to integrate CAD and RMS systems, and would fund violent crime investigative units to expand investigations and apprehension resources like the Digital Investigation Team (DIT), Radar, Star Chase Equipment, and integrating drone technology.

Public Safety Field Technology



\$20 Million Capital Request

The City of Albuquerque's past investments in field technology for APD have improved the efficiency and capacity of our field officers as they respond to violent crimes. For example, expansions in gunshot detection technology have enabled faster response times, more felony arrests, and the recovery of many stolen firearms. Between January and September 2023, over 10,000 alerts were detected by existing ShotSpotter technologies across the City of Albuquerque, resulting in arrests of violent criminals.

This request will help the City of Albuquerque to create a crime-fighting grid within the metro area, including cameras on arterial roads, gunshot detection technology expansion, and license plate readers throughout the City. This initiative would be designed to seamlessly integrate with the Real Time Crime Center to support law enforcement officers as they respond to violent crimes.

State Highways and Roads Safety Investments

This funding will support increased safety and enhance visual appeal for State highways and roads in the Metro area. The projects include:

State Highway Landscaping and Safety Fencing— \$10 Million
Funding for landscaping and safety fencing along state highways in Albuquerque.

Cleaning Equipment for State Roads— \$4 Million
Funding for cleaning equipment for state roads, including but not limited to sweepers, dump trucks, safety vehicles, etc. This initiative is essential for maintaining the cleanliness and safety of our roadways, ensuring a pleasant and secure environment for all residents and travelers.

Housing and Homelessness Capital Investments

Affordable Housing Construction



\$20 Million Capital Request

Albuquerque is facing a housing crisis. With rent and home sale prices 20% higher than 2021, many families are struggling to find housing. Half of the renters spend more than 30% of their household income on rent, and those with lowest incomes face the greatest challenges in housing options. The housing crisis is largely a supply issue – Albuquerque has a shortage of 13,000 to 28,000 housing units depending on the type of housing and income.

Last year, the City of Albuquerque launched the Housing Forward Initiative, an urgent initiative to increase the supply of housing in Albuquerque. Housing Forward sets a bold goal of adding 5,000 new units of housing above and beyond what the market would normally produce.

Housing Navigation Centers Expansion



\$10 Million Capital Request

This funding request will provide additional overnight capacity for 200 individuals each night, and enable much-needed renovations at current facilities for individuals, families, and patients unhoused by physical health or economic issues, while providing resources to allow them to recover their previous lives or make a new start.

The City of Albuquerque has seen success with a 90-day model with on-site case management and support from other agencies. Since opening in December 2020, the Family Housing Navigation Center has housed over 1,100 people or 352 families. This funding would allow the City to construct, rehabilitate, equip, and furnish additional spaces within the City of Albuquerque to expand this model.

In Albuquerque, a January Point-in-Time Count taken by community partners showed a total of 2,394 individuals experiencing homelessness, with 35% of those individuals coming to Albuquerque from other parts of New Mexico.

Placemaking Capital Investments

Rail Yards



\$25 Million Capital Request

The historic Rail Yards site, which spans across 27 acres and 17 buildings, has been an ongoing priority of the City of Albuquerque and the community. Preserving this site for future generations remains at the forefront of this funding request, which will allow remediation and stabilization of the general site for community use as well as for upgrades to the Boiler Shop to prepare for tenant readiness for economic development opportunities such as the New Mexico Media Arts Academy.

These upgrades will include replacing windows and ensuring infrastructure to connect water, sewer, electric, gas, and telecommunication utility services, as well as updates to roofs and parking areas including constructing curbs and gutters, among other things like security features.

The Rail Trail will be an iconic and artistic pedestrian parkway that reflects Albuquerque's vibrant history and cultural diversity. This bike and walking loop— being completed in segments— will be our "Trail of Enchantment" connecting Downtown, Old Town, and the Rail Yards, and connecting the residents to the wellbeing benefits of the safe trail ways.

Downtown Crossing

\$5 Million

Construction of infrastructure to allow the Rail Trail to cross Lomas Blvd.

"Eco" and "Hispanic Heritage" Sections

\$20 Million

This funding request will enable the City to acquire land and to plan, design, and construct sections to connect the Old Town to the community Bio Park, to Tingley Beach, and to National Hispanic Cultural Center, including pedestrian/bike/shuttle services.

Barelas Section

\$5 Million

The Barelas segment of the Albuquerque Rail Trail will connect the historic Albuquerque Railyards to the popular Bosque bike trail via the National Hispanic Cultural Center.

Fire Station and Facilities Construction

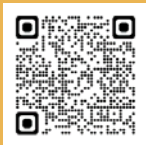
Albuquerque Fire and Rescue faces ongoing facility and equipment needs, including updates to existing stations, external infrastructure repairs, and new construction to meet growing needs. The facilities needs include:

Fire Station 12 *\$7.5 Million*
Fire Station 12, when remodeled and built out, will be a 4-bay station to serve one of the busiest parts of the City. Over 25% of AFR's call volume is in SE Albuquerque and that number has continued to rise. This funding will add critical resources, including apparatus, to the meet the needs of the southeast part of the City.

Mesa del Sol Fire Station *\$12 Million*
The Mesa del Sol community is growing, and with that growth, is in need of fire and EMS services. That was never more evident than when this summer, a massive fire demonstrated the need for additional resources in the Mesa del Sol area. This funding request is for the construction and equipping of a 3-bay fire station in Mesa del Sol in Albuquerque.

Coronado Park Fire Rescue Training and Response Center *\$5 Million*
This funding would support continued efforts to remodel Fire Station 4, which stands adjacent to Coronado Park, and establish a training facility. This would become a training facility for first responders, and a deployment site for AFR statewide HAZMAT, Wildland, and Heavy Technical Rescue Teams.

Albuquerque Police Department Substations

These two funding requests will support acquiring land and planning, designing, constructing, improving, equipping and furnishing two substations for Albuquerque Police Department in areas of Albuquerque that need capacity and improved services: in southwest Albuquerque and near the university area.

Cibola Loop Multigenerational Center



\$3 Million Capital Request

This funding request would fully fund the first phase of a new 15,000 square foot multigenerational facility located near Luna Park Street and Cibola Loop in Albuquerque's Northwest quadrant.

The Cibola Loop Multigenerational Center is a shovel-ready project. This project will be constructed in phases. The first phase will include a multipurpose room, meeting room, and classroom. Future phases will be planned.

Westgate Community Center Gymnasium



\$10 Million Capital Request

This funding request would fully fund the third phase of the Westgate Community Center, adding a 9,000 square foot gymnasium space to provide community space as well as recreation areas for youth and families.

When complete, Westgate Community Center will be a 35,000 square foot facility that will serve the Westgate community in Albuquerque's Southwest quadrant and surrounding neighborhoods.

Westside Indoor Sports Complex

The Bernalillo County Youth Sports Commission, a joint effort between the City of Albuquerque and the County previously identified the need for a new facility to support a variety of indoor sports. The City of Albuquerque has been working to make this a reality, leveraging bond and City funds with State Capital Outlay funding.

This funding will enable the Department of Parks and Recreation at the City of Albuquerque to acquire land and to plan, design, construct, improve, furnish, and equip an indoor sports complex in northwest Albuquerque.

Albuquerque Museum Education Center

This funding request will provide support for the third phase of the Albuquerque Museum's current masterplan - and represents an essential step forward for one of New Mexico's most prestigious, nationally-recognized museums. The Education Center at the Albuquerque Museum will offer classrooms, community learning spaces, student exhibition space, and an enhanced performance/presentation venue for the Museum's burgeoning education and community programs accommodating even more community residents as well as visitors to engage in education, learning, and hands-on connection with the art, artists, history, and culture of Albuquerque and New Mexico.

Program and architectural planning for the Education Center at the Albuquerque Museum is already underway.

Tijeras Arroyo BioZone Corridor



\$3.5 Million Capital Request

The City of Albuquerque is seeking funding to implement a master plan for land acquisition, trail improvements, signage, Singing Arrow archaeological site development, and Tijeras Arroyo habitat restoration.

This funding request will enable the City to plan and design a site plan and construct an educational facility for the Tijeras Biological Zone Education Center. Improvements at the recently-acquired 25-acre property that will provide a prime visitor access point and trailhead to Tijeras Canyon, as well as a small campground to introduce children and families to nature and overnight camping. It will also support upgrades to electric and water infrastructure, restore the Tijeras Arroyo, and establish a visitor education contact station.

North Domingo Baca Park Aquatic Center



\$9 Million Capital Request

LCS ID: 773

The City is requesting funding to construct an aquatic complex with an indoor Olympic pool and outdoor recreation pool at the multigenerational center. The complex will include, but not be limited to, the following features: 25-yard lap lanes, tower slides, a zero grade entry, 60-meter lanes, one-meter diving boards, one three-meter diving board, and a therapy pool with a chair lift, stairs, and a ramp.

This project will serve all generations in the surrounding neighborhoods and provide recreation and training space for families and visiting tourists alike, including USA swimming championship competitions.

Coors Boulevard – Sidewalk Improvements

Plan, design, and construct street, median and sidewalk improvements along New Mexico 45, Coors Boulevard.

Ouray Dog Park Improvements

Improve parking, facilities, and fencing at Ouray Dog Park.

Rinconada Park

Plan, design, and rehabilitate Rinconada Park.

Shawn McWethy Police Substation

Acquire land, plan, design, and construct a new or reconstruct the Shawn McWethy Substation.

West Side Indoor Sports Complex

Acquire land, plan, design, construct, furnish and equip an indoor sports complex located next to the Jennifer Riordan Baseball Complex, which may include but will not be limited to facilities for basketball, indoor soccer, wrestling, volleyball, and other recreational activities.

12th Street and Sawmill Safety Improvements

Design and construct pedestrian safety, traffic management, and traffic calming measures on 12th Street between Sawmill Road and Interstate 40.

Broadway Boulevard Streetscaping

Design and construct a streetscape and crossing on Broadway Boulevard between Lomas Boulevard and Martin Luther King Boulevard.

118th St Development

Plan, design, purchase right of way, construct and improve 118th St from Senator Dennis Chavez Blvd to Central Ave to urban arterial standards.

Route 66 Visitor Center Improvements

Plan, design, construct, expand, purchase, install signage, educational projects, historical preservation, and a walking pedestrian overlook bridge and equip a visitor center and a multi-use trail along West Central.

Southwest Public Safety Center

Plan, design, and construct the final phase of Vista Del Norte Park including a trail and expanded fields.

To acquire land, plan, design, construct, acquire right of way, furnish, equip, and install a new multigenerational facility in the Cibola Loop Complex.

2 ESTABLISHING LEGISLATIVE AND BUDGET PRIORITIES FOR THE CITY OF
3 ALBUQUERQUE FOR THE SECOND SESSION OF THE 56TH NEW MEXICO
4 STATE LEGISLATURE.

5 WHEREAS, the State of New Mexico and the City of Albuquerque, a
6 municipal subdivision of the State, are charged with providing for the public’s
7 health, welfare and safety; and

8 WHEREAS, the State of New Mexico and the City of Albuquerque strive to
9 create policies and programs to provide for just and equitable communities
10 and often share missions, and work cooperatively, to provide citizens mental
11 and physical health services, job and food security, a quality civic
12 infrastructure and a thriving and sustainable economy; and

13 WHEREAS, many of the facilities provided by, and services offered
14 through, the City of Albuquerque have a regional impact. These facilities and
15 services benefit residents of Albuquerque, Central New Mexico and citizens
16 from throughout the State. To succeed in acquiring the funds to construct and
17 improve these amenities requires a joint effort between the State of New
18 Mexico and the City of Albuquerque; and

19 WHEREAS, in recent years the most urgent and critical issues impacting
20 the City of Albuquerque, especially relating to behavioral health, criminal
21 justice, public health, housing, education and economic development
22 incentives require new state laws or amendments to existing laws for the City
23 to be able to implement programs to address these concerns; and

24 WHEREAS, the City of Albuquerque is one community created through

5 SECTION 1. The City of Albuquerque encourages the New Mexico
6 Legislature to adopt the priority policies, programs and funding as identified
7 in Attachment 1 to this Resolution and the capital requests in Attachment 2 to
8 this Resolution. Through these priorities the State and the City can further
9 their missions to provide the residents of Albuquerque, and all the people of
10 New Mexico, safe and healthy communities, quality infrastructure, and robust
11 economic development.

12 SECTION 2. The City especially urges the legislature to adopt legislation
13 that accomplishes the following:

- 14 • Furthers public safety programs and ensures equitable law enforcement
