Old Business

Update on legal review of Ordinance 10-1-2-3 confirming that the Mayor may appoint
a person who has applied to serve on the MPRAB but lies in wait because two
persons from a district have not submitted applications to fill a vacant board position
under the following conditions:

"When a vacancy occurs on the Board or no more than 30 days prior to the expiration of a member's term, the Mayor may notify the Councilor representing the District in which that member of the Board resides of the vacancy or term expiration. If that Councilor fails to nominate two members to the Board or to reappoint a member to the Board within 30 days of receiving such notification, the Mayor may appoint a member to the Board to represent that Councilor's District, subject to the advice and consent of the City Council."

 The Board identified Lavaland Park as an underutilized park for board attention this year.

- Deputy Director Flores reported:
 - o Kent Vigil selected as New Aquatics Division manager.
 - o Eric Singman hired as new Project Coordinator.
 - Cricket Tournament this weekend on new cricket pitches at Balloon Fiesta Park and another, larger tournament on Memorial Day weekend.
 - Highest volume of park projects in the history of the Department.
 - Stadium proposal at Balloon Fiesta Park will be presented before the Environmental Planning Commission next week.
 - New pickleball courts at Pat Hurley Park are very busy.
 - Los Altos Park Phase II groundbreaking is coming up.
- Deputy Director Vasquez reported:
 - Memorial Day Weekend, the Department will be coordinating or hosting major events: Pickleball Tournament with the Pros, BMX Nationals, Cricket Tournament, New Mexico Wine Festival
 - The Department has been awarded a matching grant from the State Outdoor Recreation Division to expand and improve disc golf facilities in the city. The Albuquerque Disc Golf Association has been involved in discussions that led to the grant application submission.
