

WEEKLY HOMICIDE UPDATE

This information reflects the number of homicides (cases & victims), or murder/non-negligent manslaughter, investigated by Albuquerque Police from Jan. 1 through Oct. 7, 2022. Justifiable homicides and negligent murder, as defined by the FBI, are tracked separately. Also listed are cases that are considered suspicious death investigations, where a homicide was not initially determined to be cause of death.
