- I. <u>Meeting Called to Order by Chair Evan Thompson at 12:05 PM.</u>
- II. <u>Roll Call</u>
 - a. Present:

- III. Approval of Minutes & Agenda
 - a. Mr. Shonerd motions to approve minutes, Dr. Hundley seconds. January Draft Minutes were approved.
 - b. Mr. Thompson motions to approve the February agenda; Mr. Borbas seconds. The February agenda was approved.
- IV. <u>Public Participation</u>
 - a. None.

V. <u>Bear Canyon Highlights – Tyler Dunn</u>

- a. Special Projects:
 - i. Working with City Councilor Dan Champine on updating audio system in both social halls.
 - ii. Friends of Bear Canyon group are helping fund a New Mexican-style mural.
 - iii. Starting February 26, 2025, Bear Canyon will be starting the process of accreditation.

1. Nationally-awarded event; only 300-400 senior centers are accredited nation-wide out of 6,00-7,000 senior centers.

- b. Upcoming Events:
 - i. February April 2025, every Tuesday: AARP Tax Prep Services.
 - 1. 1,000 tax prep appointments occur at 7 DSA sites over the two and a half months the Tax Prep program runs.
 - 2. Currently full for Bear Canyon.
 - ii. March 17: St. Patrick's Day Social.
 - iii. April 16: 3rd Annual Easter Event.
 - 1. Food trucks, photo booths, games, prizes, and other entertainment will be available.
- c. Bear Canyon statistics:
 - i. On average, 200 members visit a day (unduplicated visits).
 - ii. 300 new and renewal memberships were initiated last month.
 - iii. Currently, there are 2,000 2,500 active members for Bear Canyon.
 - iv. Fixed-route transportation available to take members to the senior center.
 - 1. Route includes drop-off around 8:00 A.M. for breakfast and takes members home after lunch around 12:00 P.M.
 - v. Most popular activity exercise classes like Zumba.
 - 1. Working on expanding fitness programming.
 - vi. Bear Canyon is currently fully staffed.
 - 1. 7 full-time City of Albuquerque employees
 - 2. 40-50 active volunteers, who help with the front desk, in the kitchen, and with programs such as Computer Club, Friendship Coffee, and Dessert Socials.
- VI. <u>RSVP Program Cristina Romero-Baca</u>
 - a. Retired and Senior Volunteer Program part of the AmeriCorps Seniors program.
 i. Membership is available to older adults aged 55 years and older.
 - b. At today's meeting to help enroll interested individuals who are not already members.
 - c. RSVP Orientation is offered the second Tuesday of every month at 10:00 A.M. at Barelas Senior Center.
 - d. March 9-15: AmeriCorps Week
 - As part of AmeriCorps Week, Volunteerism will be hosting a "AmeriCorps Seniors Volunteerism Fair and Pie Day" event at Manzano Mesa Multigenerational Center on March 14, 10:00 A.M. – 1:00 P.M.
 - e. Mr. Taylor: "How are our volunteer hours tracked for other RSVP events?"
 - i. Cristina: Volunteers typically input their own hours into their AmeriCorps Seniors portal.
- VII. <u>Administration Report Director Sanchez</u>
 - a. Coffee with Constituents started again for 2025.
 - i. Bear Canyon was first center to host, on February 13.

- ii. Would like to create a video montage of different activities offered at DSA Senior and Multigenerational Centers to illustrate all the programming that DSA offers.
- b. February 27: Capital Improvement Program budget meeting.
 - i. Departments present proposed projects to City Council. Approved projects will appear on November 2025 ballot.
 - ii. DSA's proposed projects:
 - 1. Funding for a new multigenerational center in City Councilor Klarissa Peña's district.
 - a. Proposed site is 15 acres in the southwest quandrant; closing on property this week.
 - 2. Northwest Multigenerational Center ("Cibola Loop") Phase I.
 - a. Large community pressure to open; currently working on opening timeline.
- c. The Area Agency on Aging provides funding at the federal level.
 - i. If federal funding cuts occur, DSA could see a 30% reduction in funding which would affect meal sites, meal programs, etc.
- VIII. <u>Committee Updates</u>
 - a. Age-Friendly Committee Agnes Vallejos
 - i. Age-Friendly Action Plan has been updated for 2025 and approved by AARP.
 - 1. Reports to City Council on a quarterly basis.
 - 2. Has a strong partnership with Planning Department which helps ensure sustainability beyond current administrations.
 - ii. Housing Forward effort exploring how to create more affordable housing throughout the city.
 - iii. Age-Friendly Action Plan is not just DSA-specific it's a City-wide plan that includes planning with other City departments.
 - 1. Current priorities: housing, civic engagement, and transportation

 - i. Mary Nance pretty robust background in healthcare IT.
