Samuel Jensen: Contact your Councilor to encourage to keep or increase transit budget.

Information Items

Aaron Sussman, Toole Design and Kelsey Walker, Toole Design presented <u>ABQ RIDE Forward Network Plan</u> <u>Phase III: Recovery Report</u>

Samuel Jensen: What happened to the non-budget revenue neutral option? How will you address demographic gap moving forward?

Andrew deGarmo: We just have decided for public input simplicity purposes now because getting back to 2019 service levels is already a little bit ambitious. Now we just focus on this recovery network because that's really what we can manage in the next couple years. We're going to make a concerted effort again to let our current riders know, we're going to be doing it all summer so it gives more time for people to learn about the effort and try to get their responses.

Aaron Sussman: We're going to keep our feedback period open through August 31.

Andrew deGarmo: This meeting was to present the report and give you a preview. A lot of this is still in motion, but we really wanted to show you guys the results of the planning effort we had put together so far. We're asking to help us spread the word. We're looking at June 5 for Stakeholder Workshop 4:30pm-6:30pm.

Samuel Jensen: We can set aside more time next month to talk about this.

Director's Report: Sandra Saiz, Fixed Route Operations Manager

Sandra Saiz: March fixed route, including ART, 553.9K passengers and 15.8K passengers for Sunvan. Budget update for Transit, our Budget submission is proposed at \$65.4 million for FY25, up from \$58.2 million in FY24. The \$7.2 Million increase includes: \$2.6M is to cover federal matching requirements for new grants that Transit has received, the primary one being for zero emission vehicles to be added to the fleet in 2027. \$1.9M for annual cost of living wage and benefit increases and mid-year positions changes. Last year, our budget was reduced by about \$5 million due to cost savings from reduced service. They have restored half of this amount or \$2.5M for our budget this year.

Adopt a Stop Community Cleanup is asking for volunteers Saturday, June 1 9am-12pm, meet at Uptown Transit Center to help clean bus stops along Route 66. All cleaning equipment will be provided.

Andrew deGarmo: Posters will be going up about San Mateo frequency. We'll be adding a bus to San Mateo Route on June 1.

They do know that they're carrying their groceries and coverage actually is more important to them in their own personal lives. I want make sure we're being respectful of transit independent riders who are brilliant and wonderful people that I talk to every day.
